## **SUMMARY ANALYSIS**

This bill is drafted by the Division of Statutory Revision of the Office of Legislative Services to adopt the Florida Statutes 2007 and designate the portions thereof that are to constitute the official statutory law of the state. The adoption act amends ss. 11.2421, 11.2422, 11.2424, and 11.2425, Florida Statutes, and provides a 1-year window for finding errors and making changes before statutory material becomes the best evidence of the law.

The 2007 adoption act will adopt all statutes material passed through the 2006 Regular Session and printed in the 2007 edition of the Florida Statutes. Legislation affecting statutory law passed in the January 2007 Special Session and the 2007 Regular Session, which will have occurred since the publication of the 2006 edition, is not adopted by the bill.

This bill has no fiscal impact.

#### **FULL ANALYSIS**

### I. SUBSTANTIVE ANALYSIS

### A. HOUSE PRINCIPLES ANALYSIS:

**Provide limited government**—The bill updates the codified statutes and removes uncertainty about the statutes governing the state.

## B. EFFECT OF PROPOSED CHANGES:

## **Current Situation**

The adoption act is enacted annually during each regular session. It prospectively adopts as an official document the edition of the Florida Statutes to be published following that session and provides a 1-year curing period for any possible errors in statutory material before it becomes the best evidence of the law. Currently, all statutes material passed through the 2005 Regular Session and printed in the 2006 edition has been adopted.

# Effect of Proposed Changes

This bill adopts all statutes material passed through the 2006 Regular Session and printed in the 2007 edition of the Florida Statutes.

#### C. SECTION DIRECTORY:

**Section 1** adopts the 2007 Florida Statutes. It includes the 2006 Florida Statutes and Reviser's Bill(s) enacted during the 2007 Legislative Session.

**Section 2** repeals all statutes enacted by the State of Florida at or prior to the 2006 regular legislative session that are not included in the 2007 Florida Statutes.

**Section 3** details that the laws adopted during the January 2007 special session and the 2007 regular session have full effect and are neither repealed by section 2 nor adopted into the 2007 Florida Statutes by section 1.

**Section 4** details that the adoption of the 2007 Florida Statues does not affect any right that accrued under a statute that was repealed by the 2007 Florida Statutes, nor will it affect any civil remedy where a suit is pending.

**Section 5** provides for an effective date.
