SUMMARY ANALYSIS

Section 5 of Article XI of the Florida Constitution provides that proposed amendments to the constitution are to be submitted to the electors at a general election. However, pursuant to a law enacted by the affirmative vote of three-fourths of the membership of each house, the legislature may submit a proposed amendment to the voters at a special election held no sooner than ninety days after the proposed amendment is filed with the custodian of state records.

The bill provides for a special election to be held on the first Tuesday after the first Monday in November 2007 (November 6) to submit to the electors for approval or rejection House Joint Resolution 7207.

HJR 7207 provides for the ability of homeowners to transfer their Save Our Homes benefit when they establish a new homestead, under certain circumstances.

The Department of State has estimated that the statewide cost of holding a special election is \$23,112,598. The bill does not specify who will pay for the special election.

However, pursuant to a law enacted by the affirmative vote of three-fourths of the membership of each house, the legislature may submit a proposed amendment to the voters at a special election held no sooner than ninety days after the proposed amendment is filed with the custodian of state records.

The bill provides for a special election to be held on the first Tuesday after the first Monday in November 2007 to submit to the electors for approval or rejection HJR 7207.

HJR 7207 provides for the ability of homeowner's to transfer their Save Our Homes benefit when they establish a new homestead, under certain circumstances.
