A bill to be entitled 1 2 An act for the relief of Jennifer Graham by the 3 Palm Beach County Sheriff's Office; providing for an appropriation to compensate Jennifer 4 5 Graham for injuries sustained as a result of 6 the negligence of the sheriff's office; 7 requiring the purchase of a specified 8 structured annuity and structured educational 9 fund; providing for attorney's fees, lobbyist's fees, and costs; providing an effective date. 10 11 WHEREAS, on June 15, 2003, 29-year-old Jennifer Graham 12 13 was seated on a park bench on the southwest corner of Park 14 Avenue located in Palm Beach County, Florida, and WHEREAS, a deputy sheriff of the Palm Beach County 15 Sheriff's Office was traveling westbound on Park Avenue at 16 approximately 60 to 70 miles per hour according to an 17 18 eyewitness, and WHEREAS, when the deputy sheriff attempted to make a 19 left turn at this high rate of speed, he lost control of his 20 vehicle and collided with the park bench and Jennifer Graham, 21 22 and 23 WHEREAS, Ms. Graham was thrown approximately 30 feet 24 due to the collision and landed on a concrete sidewalk, and WHEREAS, the Palm Beach County Sheriff's Office 25 investigated the accident and determined that the deputy 26 sheriff was the sole contributing cause of the accident by 27 28 exceeding a safe speed and losing control of the vehicle while 29 attempting to make a left turn, and 30 WHEREAS, Ms. Graham suffered multiple pelvic fractures 31 and a bladder rupture, for which she had immediate surgery; a

left acetabulum fracture; a right sacroiliac joint fracture; a 1 2 pelvic hematoma; and an open laceration from her stomach to her pubic bone, and 3 4 WHEREAS, as a result of her injuries, Ms. Graham later underwent multiple surgeries to repair a hernia, a left 5 shoulder joint, and the pelvic and iliosacral fractures, the б 7 latter requiring hardware and screw fixation, and 8 WHEREAS, Ms. Graham was admitted to two rehabilitation 9 facilities for a total of approximately 5 months where she was diagnosed with chronic pain, gait dysfunction, and depression, 10 and 11 WHEREAS, as a result of the accident, Ms. Graham 12 13 sustained a 40-percent permanent functional impairment and 14 permanent gait dysfunction, and WHEREAS, due to the severity of her injuries, Ms. 15 Graham cannot maintain employment and will require future 16 medical care over her lifetime and an additional surgery to 17 18 remove the hardware that was placed in her pelvis and 19 iliosacral joint, and WHEREAS, Ms. Graham's medical expenses resulting from 20 this accident were \$266,462.44 and the Palm Beach County 21 22 Health Care District has paid a portion of the outstanding 23 medical expenses, but has imposed a lien in the amount of 24 \$87,937.31, and WHEREAS, the present value of Ms. Graham's total 25 economic damages over her lifetime was calculated to be 26 \$1,018,988.40; however, the expert economist hired by the Palm 27 28 Beach County Sheriff's Office calculated the value to be 29 \$771,670, and 30 WHEREAS, Ms. Graham is also entitled to collect damages 31 for her past and future pain and suffering, mental anguish,

disability, and loss of enjoyment of life resulting from the 1 2 devastating injuries and severe impairment she incurred as a result of the accident, and 3 4 WHEREAS, Ms. Graham filed a lawsuit against the Palm 5 Beach County Sheriff's Office, and a trial was set to begin on July 18, 2005, and б 7 WHEREAS, on July 13, 2005, Ms. Graham and the Palm 8 Beach County Sheriff's Office entered into an agreement to settle the lawsuit in the amount of \$950,000, of which the 9 sheriff's office paid \$100,000 at the time the settlement 10 agreement was signed by all parties, NOW, THEREFORE, 11 12 13 Be It Enacted by the Legislature of the State of Florida: 14 Section 1. The facts stated in the preamble to this 15 act are found and declared to be true. 16 The Palm Beach County Sheriff's Office is 17 Section 2. 18 authorized and directed to pay to Jennifer Graham, out of 19 insurance proceeds or out of moneys appropriated by the sheriff's office from funds of the sheriff's office not 20 otherwise encumbered, the sum of \$850,000 for injuries and 21 22 damages sustained due to the negligence of the Palm Beach County Sheriff's Office in the following manner, as agreed to 23 24 by the parties in their settlement agreement: (1) Three hundred fifty thousand dollars, paid within 25 20 days after notice to the Palm Beach County Sheriff's Office 26 upon the effective date of this act; 27 28 (2) Two hundred fifty thousand dollars, paid 1 year 29 following the date of the payment of the first payment of 30 <u>\$350,000; and</u> 31

3	Section 3. (1) Within 20 days of the effective date								
4	of this act, Jennifer Graham shall purchase a structured								
5	settlement annuity at a cost of no less than \$75,000 for the								
6	exclusive use and benefit of her minor children, Ashley								
7	Graham, Tyler Graham, and Hunter Graham. Pursuant to the terms								
8	of the annuity, each child shall be guaranteed monthly								
9	payments beginning on the month following the effective date								
10	of this act and ending on each child's 18th birthday. Such								
11	funds are to follow the children regardless of who their legal								
12	custodians are, where the children are living, or Jennifer								
13	Graham's legal status as a parent, and shall be in addition to								
14	any child support payments that may be owed or owing by								
15	Jennifer Graham.								
16	(2) Within 13 months of the effective date of this								
17	act, Jennifer Graham shall purchase a structured educational								
18	fund at a cost to Jennifer Graham of no less than \$45,000.								
19	Such fund shall provide a semiannual benefit to each of her								
20	three minor children, Ashley Graham, Tyler Graham, and Hunter								
21	Graham, for 4 years each, beginning on each child's 18th								
22	birthday. Such funds are to follow the children regardless of								
23	who their legal custodians are, where the children are living,								
24	or Jennifer Graham's legal status as a parent, and shall be in								
25	addition to any child support payments that may be owed or								
26	owing by Jennifer Graham.								
27	Section 4. Payment for attorney's fees and costs
