Paragraph (1) is added to subsection (2) of section 849.086, Florida Statutes, paragraph (d) of subsection 15 (5), subsections (7) and (8), paragraph (h) of subsection 16 (13), and subsection (16) of that section are amended, to 17 18 read: 849.086 Cardrooms authorized.--19 (2) DEFINITIONS.--As used in this section: 20 (1) "Tournament" means a series of games that have 21 22 more than one betting round involving one or more tables and 23 where the winners or others receive a prize or cash award. 24 (5) LICENSE REQUIRED; APPLICATION; FEES. -- No person may operate a cardroom in this state unless such person holds 25 a valid cardroom license issued pursuant to this section. 26 (d) The annual cardroom license fee for each facility 27 28 shall be \$1,000 for the first table and \$500 for each 29 additional table to be operated at the cardroom. The This license fee shall be deposited by the division with the Chief 30 31

(b) Any horserace, greyhound race, or jai alai 10 permitholder licensed under this section may operate a 11 cardroom at the pari-mutuel facility on any day for a 12 13 cumulative amount of 12 hours if the permitholder meets the 14 requirements under paragraph (5)(b). A cardroom may be operated at the facility only when the facility is authorized 15 to accept wagers on pari mutuel events during its authorized 16 17 meet. A cardroom may operate between the hours of 12 noon and 18 12 midnight on any day a pari mutuel event is conducted live 19 as a part of its authorized meet. However, a permitholder who holds a valid cardroom license may operate a cardroom between 20 the hours of 12 noon and 12 midnight on any day that live 21 22 racing of the same class of permit is occurring within 35 23 miles of its facility if no other holder of that same class of 24 permit within 35 miles is operating a cardroom at such time and if all holders of the same class of permit within the 25 26 35 mile area have given their permission in writing to the 27 permitholder to operate the cardroom during the designated 28 period. (c) A cardroom operator must at all times employ and 1 2 provide a nonplaying dealer for each table on which authorized 3 card games which traditionally use utilize a dealer are 4 conducted at the cardroom. Such dealers may not have <u>a</u> any participatory interest in any game other than the dealing of 5 б cards and may not have an interest in the outcome of the game. 7 The providing of such dealers by a licensee <u>does</u> shall not 8 constitute be construed as constituting the conducting of a 9 banking game by the cardroom operator. 10 (d) A cardroom operator may award giveaways, jackpots,

and prizes to a player who holds certain combinations of cards 11 specified by the cardroom operator. 12

13 (e) (d) Each cardroom operator shall conspicuously post 14 upon the premises of the cardroom a notice which contains a copy of the cardroom license; a list of authorized games 15 offered by the cardroom; the wagering limits imposed by the 16 house, if any; any additional house rules regarding operation 17 18 of the cardroom or the playing of any game; and all costs to 19 players to participate, including any rake by the house. Games may only be played utilizing a 5 wagering system whereby all players' money is first converted б 7 by the house to tokens or chips which shall be used for 8 wagering only at that specific cardroom. 9 (b) The cardroom operator may limit the amount wagered in any game or series of games, but the maximum bet may not 10 $exceed_{55}$ in value. There may not be more than three raises 11 in any round of betting. The fee charged by the cardroom for 12 13 participation in the game shall not be included in the 14 calculation of the limitation on the bet amount provided in this paragraph. However, a cardroom operator may conduct games 15 of Texas Hold-em without a betting limit if the required 16 player buy-in is no more than \$100. 17 18 (c) A tournament shall consist of a series of games. 19 The entry fee for a tournament, including any re-buys, may not exceed the maximum amount that could be wagered by a 20 participant in 10 like-kind, nontournament games under 21 22 paragraph (b). Tournaments may be played only with tournament 23 chips that are provided to all participants in exchange for an 24 entry fee and any subsequent re-buys. All players must receive an equal number of tournament chips for their entry fee. 25 Tournament chips have no cash value and represent tournament 26 points only. There is no limitation on the number of 27 28 tournament chips that may be used for a bet except as 29 otherwise determined by the cardroom operator. Tournament chips may never be redeemed for cash or for any other thing of 30 value. The distribution of prizes and cash awards must be 31

determined by the cardroom operator before entry fees are 1 2 accepted. For purposes of tournament play only, the term "gross receipts" means the total amount received by the 3 cardroom operator for all entry fees, player re-buys, and fees 4 for participating in the tournament less the total amount paid 5 to the winners or others as prizes. б 7 (13) TAXES AND OTHER PAYMENTS.--8 (h) One-quarter of the moneys deposited into the 9 Pari-mutuel Wagering Trust Fund pursuant to paragraph (g) shall, by October 1 of each year, be distributed to the local 10 government that approved the cardroom under subsection (16) 11 counties in which the cardrooms are located; however, if two 12 13 or more pari-mutuel racetracks are located within the same 14 incorporated municipality, the cardroom funds shall be distributed to the municipality. If a pari-mutuel facility is 15 situated in such a manner that it is located in more than one 16 county, the site of the cardroom facility shall determine the 17 18 location for purposes of disbursement of tax revenues under 19 this paragraph. The division shall, by September 1 of each year, determine: the amount of taxes deposited into the 20 21 Pari-mutuel Wagering Trust Fund pursuant to this section from 22 each cardroom licensee; the location by county of each 23 cardroom; whether the cardroom is located in the 24 unincorporated area of the county or within an incorporated municipality; and, the total amount to be distributed to each 25 eligible county and municipality. 26 (16) <u>LOCAL GOVERNMENT</u> COUNTY COMMISSION APPROVAL.--The 27 28 Division of Pari-mutuel Wagering shall not issue any initial 29 license under this section except upon proof in such form as the division may prescribe that the local government where the 30 applicant for such license desires to conduct cardroom gaming 31

has voted to approve such activity by a majority vote of the governing body of the municipality or the governing body of the county if the facility is not located in a municipality a majority of the county commissioners in the county where the applicant for such license desires to conduct cardroom gaming б has voted to approve such activity within the county. Section 2. For the 2007-2008 fiscal year, four full-time equivalent positions and 138,949 in associated salary rate are authorized, and the sums of \$230,722 in recurring funds and \$48,411 in nonrecurring funds are appropriated from the Pari-mutuel Wagering Trust Fund of the Department of Business and Professional Regulation for the purpose of carrying out activities related to this act. Section 3. This act shall take effect July 1, 2007.
