Section 1. The present corporate limits of the City of Lauderhill, Broward County, are hereby contracted so as to voluntarily deannex and exclude from the territory presently within its corporate limits the area consisting of a commercial parcel more commonly known as the Renaissance Evangelical Baptist Tabernacle parking lot (Folio #504206010010), 3741 West Broward Boulevard, together with a portion of the abutting right-of-way on Broward Boulevard to be annexed into the City of Plantation, particularly described as follows:

Section 4. All public roads and the public rights-of-way associated therewith, on the Broward County road system, lying within the limits of the lands subject to annexation herein, are transferred from Broward County jurisdiction to the jurisdiction of the annexing municipality upon the effective date of the annexation.

Section 5. On the effective date of this act, the annexing municipality shall be responsible for and embodied with all municipal powers granted in chapter 166, Florida Statutes, including, but not limited to, police powers, over the territory hereby annexed.

Section 6. Nothing in this act shall be construed to affect or abrogate the rights of parties to any contracts, including contracts between nongovernmental entities, which contracts are in effect prior to the effective date of the annexation.

Section 7. This act shall take effect upon becoming a law.
