A bill to be entitled

An act relating to physical education; amending s. 1001.11, F.S.; requiring the Commissioner of Education to dedicate resources to provide professional development to physical education teachers and curricula developers; amending s. 1003.01, F.S.; defining the term "physical education"; amending s. 1003.455, F.S.; requiring district school boards to provide specified physical education for certain students; requiring reporting for funding purposes and auditing of records; requiring the State Board of Education to review and revise the Sunshine State Standards related to physical education; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsection (7) is added to section 1001.11, Florida Statutes, to read:

1001.11 Commissioner of Education; other duties. --

(7) The commissioner shall dedicate financial and departmental staff resources to provide professional development to physical education teachers, elementary and secondary teachers whose assignments include physical education courses, and developers of physical education curricula. Such professional development shall incorporate current physical education and nutrition philosophy and best practices that result in student participation in physical activities that promote lifelong physical and mental well-being.

Section 2. Subsection (16) is added to section 1003.01, Florida Statutes, to read:

- 1003.01 Definitions.--As used in this chapter, the term:
- (16) "Physical education" means the development or maintenance of skills related to strength, agility, flexibility, movement, and stamina, including dance; the development of knowledge and skills regarding teamwork and fair play; the development of knowledge and skills regarding nutrition and physical fitness as part of a healthy lifestyle; and the development of positive attitudes regarding sound nutrition and physical activity as a component of personal well-being.
- Section 3. Subsection (3) of section 1003.455, Florida Statutes, is amended to read:
  - 1003.455 Physical education; assessment.--
- of physical education each week for students in kindergarten through grade 5. Students enrolled in such instruction shall be reported through the periodic student membership surveys, and records of such enrollment shall be audited pursuant to s.

  1010.305. Each district school board is encouraged to provide 150 minutes of physical education each week for students in kindergarten through grade 5 and 225 minutes of physical education each week for students in education each week for students in grades 6 through 8.
- Section 4. <u>During the 2007-2008 school year, the State</u>
