An act relating to specialty license plates; amending s. 320.08056, F.S.; establishing annual use fees for the Support Our Troops license plate and the Florida NASCAR license plate; authorizing placement of a sponsoring organization's Internet domain name on specialty license plates; requiring the specialty license plate application form to provide the applicant the option to instruct the Department of Highway Safety and Motor Vehicles to provide certain information to the sponsoring organization; amending s. 320.08058 , F.S.; creating the Support Our Troops license plate; requiring the use of certain images and marks of Support Our Troops, Inc.; providing that the right to use a certain mark is reserved to that corporation; authorizing that corporation to change the design of the Support Our Troops license plate under certain circumstances; providing that issuance of the Support Our Troops license plate shall not be discontinued if the number of registrations falls below a certain number; providing for the distribution of use fees received from the sale of such plates to Support Our Troops, Inc.; creating the Florida NASCAR license plate; providing for the distribution of use fees received from the sale of such plates to the Florida Sports Foundation, the National Association for Stock Car Auto Racing, and the NASCAR Foundation; requiring the Florida Sports Association to provide for an annual audit to be submitted to the Office of Tourism, Trade, and Economic Development
for certification to the Auditor General; providing an effective date.

WHEREAS, to create a concrete statement of thanks to our troops for their service, civilians stepped forward and founded Support Our Troops, Inc., a national nonprofit organization based in Florida and dedicated to permanently assisting active duty troops and their families, and

WHEREAS, through a comprehensive program that enables individuals to offer support through multiple charitable methodologies, Support Our Troops, Inc., provides the means through which individuals may take direct personal financial responsibility for their troops and engage in direct financial assistance for the troops and their families, and

WHEREAS, Support Our Troops, Inc., also provides the means through which people may publicly display support for their troops, and

WHEREAS, the Support Our Troops license plate will serve these very important functions and will, by example, encourage others to do the same, and

WHEREAS, the NASCAR Foundation is committed to helping improve the lives of people, including those in need, and

WHEREAS, the NASCAR Foundation endeavors to create as many avenues as possible through which people can enrich the lives of children with chronic and medical conditions or serious illnesses, assist children in need, educate and inspire, and advance family values among youth, and

WHEREAS, the Florida NASCAR license plate will serve these very important functions and will, by example, encourage others to do the same, NOW, THEREFORE,

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsection (6) of section 320.08056, Florida Statutes, is amended, paragraphs (iii) and (jjj) are added to subsection (4), and subsection (11) is added to that section, to read:
320.08056 Specialty license plates.--
(4) The following license plate annual use fees shall be collected for the appropriate specialty license plates:
(iii) Support Our Troops license plate, \$25.
(jjj) Florida NASCAR license plate, \$25.
(6) Specialty license plates must bear the design required by law for the appropriate specialty license plate, and the designs and colors must conform to the department's design specifications. In addition to a design, the specialty license plates may bear the imprint of numerals from 1 to 999, inclusive, capital letters "A" through "Z," or a combination thereof. The department shall determine the maximum number of characters, including both numerals and letters. All specialty license plates must be otherwise of the same material and size as standard license plates issued for any registration period. A specialty license plate may bear an appropriate slogan, emblem, or logo in a size and placement that conforms to the

department's design specifications. The sponsoring organization's Internet domain name may appear on the plate.
(11) The application form for a specialty license plate shall provide the applicant the option to instruct the department to provide his or her name, address, and renewal date to the sponsoring organization.

Section 2. Subsections (61) and (62) are added to section 320.08058, Florida Statutes, to read:
320.08058 Specialty license plates.--
(61) SUPPORT OUR TROOPS LICENSE PLATES.--
(a) The department shall develop a Support Our Troops license plate as provided in this section. Support Our Troops license plates must bear the colors and design approved by the department and must contain the soldier and child emblem and "Support Our Troops" marks of Support Our Troops, Inc. The right to use the mark of an eagle head upon a United States flag field on a specialty license plate is reserved to Support Our Troops, Inc., and such mark may be used alternatively. The word "Florida" must appear on the plate and may be in approximately 85-point Mistral font, and the words "Support Our Troops" must appear on the plate and may be in approximately 60-point Vandijk font. Upon compliance with s. 320.08056(9), Support Our Troops, Inc., may alternate the phrase at the bottom of the plate to "Support Our Heroes" or "Salute Our Heroes." The field of the plate may be colored.
(b) The license plate annual use fees shall be distributed to Support Our Troops, Inc., to be used for the benefit of Florida troops and their families in accordance with its

articles of incorporation. Support Our Troops, Inc., may retain all revenue from the annual use fees until all startup costs for developing and establishing the plate have been recovered. Thereafter, up to 25 percent of the annual use fee revenue may be used for administrative costs and promotion and marketing of the specialty license plate.
(c) Notwithstanding s. 320.08056, the department shall begin production and distribution of the Support Our Troops specialty license plate within 90 days after its approval by the Legislature. Section $320.08056(8)(a)$ shall not apply to the Support Our Troops license plate. The Support Our Troops license plate shall also be issued in similar design in a size appropriate for motorcycles.
(62) FLORIDA NASCAR LICENSE PLATES.--
(a) The department shall develop a Florida NASCAR license plate as provided in this section. Florida NASCAR license plates must bear the colors and design approved by the department. The word "Florida" must appear at the top of the plate, and the term "NASCAR" must appear at the bottom of the plate. The National Association for Stock Car Auto Racing, following consultation with the Florida Sports Foundation, may submit a sample plate for consideration by the department.
(b) The license plate annual use fees shall be distributed to the Florida Sports Foundation, a direct-support organization of the Office of Tourism, Trade, and Economic Development. The license plate annual use fees are to be annually allocated as follows:

1. Up to 5 percent of the proceeds from the annual use Page 5 of 6

fees may be used by the Florida Sports Foundation for the administration of the NASCAR license plate program.
2. The National Association for Stock Car Auto Racing shall receive up to $\$ 80,000$ in proceeds from the annual use fees to be used to pay startup costs, including costs incurred in developing and issuing the plates. Thereafter, 10 percent of the proceeds from the annual use fees shall be provided to the association for the royalty rights for the use of their marks.
3. The remaining proceeds from the annual use fees shall be distributed to the Florida Sports Foundation. The Florida Sports Foundation will retain 15 percent to support their regional grant program, attracting sporting events to Florida; 20 percent to support the marketing of motorsports-related tourism in the state; and 50 percent to be paid to the NASCAR Foundation, an s. 501 (c) (3) charitable organization, to support Florida-based charitable organizations.
(c) The Florida Sports Foundation shall provide an annual financial audit in accordance with s. 215.981 of its financial accounts and records by an independent certified public accountant pursuant to the contract established by the Office of Tourism, Trade, and Economic Development as specified in s. 288.1229(5). The auditor shall submit the audit report to the Office of Tourism, Trade, and Economic Development for review and approval. If the audit report is approved, the office shall certify the audit report to the Auditor General for review.

Section 3. This act shall take effect July 1, 2007.
