the top of the plate, and the words "Confederate Heritage" must appear at the bottom of the plate.

- (b) The license plate annual use fees shall be distributed to Sons of Confederate Veterans, Florida Division, Inc., to fund educational programs in schools, cemetery location and restoration, educational scholarship programs, and other projects within the state promoting Florida's history and heritage. Sons of Confederate Veterans, Florida Division, Inc., may retain all revenue from the annual use fees until all startup costs for developing and establishing the plate have been recovered. Thereafter, up to 5 percent of the annual use fee revenue may be used for administrative costs directly associated with operations of Sons of Confederate Veterans, Florida Division, Inc., and up to 20 percent may be used for promotion and marketing of the specialty license plate.
- Section 3. Section 320.0841, Florida Statutes, is amended to read:
- 320.0841 Free motor vehicle license plates to members of <a href="Motorway">Choctaw</a>, Seminole, and Miccosukee Indian Tribes.--
- (1) The department shall issue each year, free of charge to any state agency or individual, a sufficient number of motor vehicle license plates for use on vehicles owned and operated by members of the <a href="Choctaw">Choctaw</a>, Seminole, and Miccosukee Indian Tribes. The allocation for any year may be increased by an amount equal to up to 10 percent of the allocation for the previous year. Any request for such increase shall be accompanied by formal certification of the need therefor by the <a href="Choctaw">Choctaw</a>, Seminole, or <a href="and Miccosukee Tribal Council">and Miccosukee Tribal Council</a>, as appropriate <a href="Councils">Councils</a>.
