SUMMARY ANALYSIS

The Port of Palm Beach District is an independent special district in Palm Beach County. This bill amends the district's special act to increase the annual salary of port commissioners from \$9,500 to \$19,000.

The bill provides an effective date of upon becoming a law.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

This bill does not appear to implicate any of the House Principles.

B. EFFECT OF PROPOSED CHANGES:

Present Situation

The Port of Palm Beach District is an independent special district in Palm Beach County. The port district board consists of five commissioners, each elected by a district wide vote of the qualified electors for four-year terms. All members of the board are required to be duly qualified voters of Palm Beach County, citizens of the United States, and reside within district limits. In 1999, the salary of each commissioner was increased from \$4,800 to \$9,500.

For the fiscal year ending September 30, 2006, the district had gross operating revenues of 13 million, and operating expenses of 12.5 million. Revenues were obtained from wharfage, rent dockage, parking, cruise and cargo terminal fees, security fees, etc. ³ The port also received \$799,904 in federal grants and \$1,824,061 in state grants.⁴

Port administration⁵ has advised that:

- it examined similar boards (such as small local municipalities and port governing boards) and determined that an annual salary of \$19,000 per commissioner "is in line" with average compensation;
- port commissioners around the state and country now participate more fully in industry and community meetings;
- Port of Palm Beach commissioners all attend three to four programs/meetings each month, whereas a decade ago they only went to one meeting per month; and
- this proposal will not impact taxpayers.

Effect of Proposed Changes

This bill amends a special act relating to the Port of Palm Beach District to increase the annual salary of district commissioners from \$9,500 to \$19,000.

The bill provides an effective date of upon becoming law.
