## **SUMMARY ANALYSIS**

The Pension Fund of the Fire Department of the City of Clearwater (Fund) has existed since 1939. Consequently, the special act contains some outdated terminology and gender references such as fireman and chairman. #### **FULL ANALYSIS**

#### I. SUBSTANTIVE ANALYSIS

### A. HOUSE PRINCIPLES ANALYSIS:

#### **Current Situation**

The Pension Fund of the Fire Department of the City of Clearwater (Fund) has existed since 1939.<sup>1</sup> Consequently, the special act contains some outdated terminology and gender references such as fireman and chairman. Also, the Fund has a problem finding participants to serve on the Board because it has been closed to new participants since July 1, 1963.

### **Effect of Proposed Changes**

HB 1089 updates terminology such as secretaries and stenographers to staff assistants and revises gender references such as his to his or her, fireman to firefighter and chairman to chairperson. The bill also revises the membership of the Board such that if no member of the Fund is available, then a current firefighter of the fire department below the rank of chief who is willing to serve may be placed on the ballot. If no one is available to stand for election, or no one is available to participate in the voting, then members of the board will be appointed by the city council.

In addition, because of diminished activity in the Fund the bill amends the actuarial valuation requirement from annual to not more than three years.

Section 1: Revises terminology; revises requirements for membership on the board; revises actuarial valuation from annual to not more than three years.

Section 2: Provides an effective date of upon becoming law.

This plan and the employees covered by the plan was frozen in 1963 when the city of Clearwater formed a new pension plan for all city employees. Since that date in 1963, the eligible participants of the plan have been elected as members of the Board of the plan for two of the five positions. Now some 45 years later, eligible members with the ability to serve as an elected Board member are becoming difficult to find. This Bill addresses this hardship as well as updated language necessary for gender conforming correctness. This pension is fully funded and requires no additional funds from the City of Clearwater or any surviving participant.
