SUMMARY ANALYSIS

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not "officially" change the current names of the facilities, nor does the statute require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings.

HB 1465 designates the following transportation facilities:

- That portion of Edgewood Avenue East between Beaver Street and Roosevelt Boulevard in Duval County is designated as "John E. Andrews Avenue"
- That portion of Wilson Boulevard between Interstate Highway 295 South and Old Middleburg Road in Duval County is designated as "George Matthews Boulevard".
- That portion of New Kings Road between Davis Street and Myrtle Avenue in Duval County is designated as "Angela Webbs Hammonds Road."
- That portion of Martin Luther King, Jr. Boulevard between Myrtle Avenue and Moncrief Road in Duval County is designated as "Willie F. Faust Boulevard."
- That portion of N.W. 135th Street between N.W. 7th Avenue and N.W. 27th Avenue in Miami-Dade County is designated as "Bishop Victor Tyrone Curry Boulevard."
- That portion of N.W. 135th Street between N.W. 7th Avenue and N.W. 47th Avenue in Miami-Dade County is designated as "Honorable Robert B. Ingram, Ph.D. Boulevard."
- That portion of N.W. 7th Avenue between N.W. 35th Street and N.W. 79th Street in Miami-Dade County is designated as "Dr. Barbara Carey-Shuler Avenue."
- That portion of West Flagler Street between 13th Avenue and 14th Avenue in Miami-Dade County is designated as "Father Emilio Vallina Avenue."
- That portion of State Road 836 between 97th Avenue and 137th Avenue in Miami-Dade County is designated as "MSgt. Benjamin Strickland Highway."
- That portion of W. Okeechobee Road between W. 4th Avenue and Palm Avenue in Miami-Dade County is designated as "Willy Chirino Boulevard."

The Florida Department of Transportation (FDOT) is directed to erect suitable markers designating the honorary road. The markers will cost an estimated \$400 each. Assuming that two markers will be erected for the designation, the estimated fiscal impact to FDOT will be \$8,000. This includes maintenance and installation costs.

HB 1465 does not create any constitutional or other legal issues. It takes effect July 1, 2008.

On March 13, 2008, the Committee on Tourism and Trade adopted 1 amendment by the bill sponsor that added the following road designations:

- That portion of S.E. 2nd Avenue from the Miami River south to S.E. 2nd Street in Miami-Dade County is designated as "Avenue of the Americas."
- The portion of state road 934/in Miami-Dade County N.W. 79th Street between N.W. 7th Avenue and N.W. 37th Avenue as "Rev. Dr. C.P. Preston, Jr. Street."
- That portion of 71st Street between Collins Avenue and Bay Drive in the City of Miami Beach in Miami-Dade County is designated as "Henri Levy Boulevard."
- That portion of S.W. 59th Avenue between S.W. 80th Street and S.W. 72nd Street in Miami-Dade County is designated as "American Legion Way."
- That portion of U.S. Highway 1 from S.W. 136th Street to and including S.W. 184th Street in Miami-Dade County is designated as "Palmetto Bay Boulevard."
- That portion of S.W. 72nd Avenue between S.W. 21st Street and North Waterway Drive in Miami-Dade County is designated as "Manuel Feijoo Avenue."
- That portion of U.S. Highway 1 between S.W. 80th Street and S.W. 57th Avenue in Miami-Dade County designated as "South Miami All-American Parkway" by chapter 2003-298, Laws of Florida, is redesignated as "All America Parkway."
- That portion of 12th Avenue between 8th Street S.W. and 64th Street N.W. in Miami-Dade County is designated as "Katherine Fernandez Rundle Avenue."
- The portion of SR 789/Gulf Stream Avenue between Sunset Drive and Bird Key Drive in Sarasota County is designated as the "Gil Waters Bridge."

The amendment will increase the fiscal impact of the bill on FDOT to \$15,200.

FULL ANALYSIS

I. SUBSTANTIVE ANALYSIS

A. HOUSE PRINCIPLES ANALYSIS:

This bill does not implicate any of the House Principles.

B. EFFECT OF PROPOSED CHANGES:

Current Situation

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not "officially" change the current names of the facilities, nor does the statute require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings.

The statute requires the Florida Department of Transportation (FDOT) to place a marker at each terminus or intersection of an identified road or bridge, and to erect other markers it deems appropriate for the transportation facility. The statute also provides that a city or county must pass a resolution in support of a particular designation before road markers are erected. Additionally, if the designated road segment extends through multiple cities or counties, a resolution must be passed by each affected local government.

Based on FDOT records, over 1,100 honorary road and bridge designations have been approved since 1922, most of them by the Legislature. Some public roads and bridges have multiple or overlapping designations.

Proposed Changes

HB 1465 designates the following transportation facilities:

- That portion of Edgewood Avenue East between Beaver Street and Roosevelt Boulevard in Duval County is designated as "John E. Andrews Avenue"
- That portion of Wilson Boulevard between Interstate Highway 295 South and Old Middleburg Road in Duval County is designated as "George Matthews Boulevard".

The bill takes effect July 1, 2008.

FDOT estimates that the total cost to erect two suitable road designating markers for each designation, a total of 20 markers, is approximately \$8,000, this assumes the placement of a marker at each end of the designated road segment. The expenditure is from the State Transportation Trust Fund and includes installation and maintenance costs.
