House Bill 1525 amends s. 430.502(1)(e), F.S., changing the name of "the East Central Florida memory Disorder Clinic at the Joint Center for Advanced Therapeutics and Biomedical Research of the Florida Institute of Technology and Holmes Regional medical Center, Inc." to "The Memory Disorder Clinic, Inc., operating in Brevard County."

The bill has no direct fiscal impact on state funds.

The bill provides an effective date of July 1, 2008.

# **Present Situation**

There are 15 memory disorder clinics in Florida. These clinics are mandated by statute to provide comprehensive assessments, diagnostic services, and treatment to individuals who exhibit symptoms of Alzheimer's disease-related memory disorders. These clinics also develop training programs and disease-related materials and conduct training for caregivers, respite service providers and health care professions in the care of persons with Alzheimer's disease and related memory disorders.

In 1995, the Legislature designated The East Central Florida Memory Disorder Clinic at the Joint Center for Advanced Therapeutics and Biomedical Research of the Florida Institute of Technology and Holmes Regional Medical Center, Inc. (East Central Florida Memory Clinic or "Clinic"), as one of the memory disorder centers to receive state funding.<sup>2</sup> Recently, the clinic changed its formal, corporate name to the Memory Disorder Clinic, Inc.<sup>3</sup>

The East Central Florida Memory Clinic covers a service area that includes Brevard, Indian River, Osceola, Southern Volusia, and St. Lucie counties. It is a collaborative effort between Health First, Inc., and the Florida Institute of Technology. Health First Inc. has overseen the Clinic's fiduciary duties since 1998. As part of Holmes Regional Medical Center, the Clinic must comply with all policies and procedures of the Joint Commission on Accreditation of Healthcare Organization (JCAHO) hospital. HIPPA, and Health First.4

The Clinic provides services including comprehensive memory evaluations, caregiver education, support groups, and training and assessments for medically at-risk drivers.<sup>5</sup>

The East Central Florida memory Disorder Clinic at the joint Center for Advanced Therapeutics and biomedical Research of the Florida Institute of Technology and Holmes Regional Medical Center., Inc. will be renamed "the Memory Disorder Clinic, Inc., operating in Brevard County."
