18	rental of an entire dwelling previously claimed to be a homestead
19	for tax purposes shall constitute the abandonment of the said
20	dwelling as a homestead, and said abandonment shall continue
21	until <u>the</u> <del>such</del> dwelling is physically occupied by the owner <u>of</u>
22	the dwelling thereof. However, such abandonment of such homestead
23	after January 1 of any year <u>does</u> <del>shall</del> not affect the homestead
24	exemption for tax purposes for that particular year $\mathrm{if}$ so long as
25	this provision is not used for 2 consecutive years. The
26	provisions of this section <u>do</u> <del>shall</del> not apply to <u>:</u>
27	(1) A member of the Armed Forces of the United States whose
28	service in such forces is the result of a mandatory obligation
