1 A bill to be entitled

2 An act implementing the 2008-2009 General Appropriations  
3 Act; providing legislative intent; incorporating by  
4 reference certain calculations of the Florida Education  
5 Finance Program for the 2008-2009 fiscal year; providing  
6 for the effect of a veto of one or more specific  
7 appropriations or proviso provisions to which implementing  
8 language refers; providing for the continued operation of  
9 certain provisions notwithstanding a future repeal or  
10 expiration provided by the act; providing for  
11 severability; providing for contingent retroactive  
12 application; providing effective dates.

14 Be It Enacted by the Legislature of the State of Florida:

15  
16 Section 1. It is the intent of the Legislature that the  
17 implementing and administering provisions of this act apply to  
18 the act making appropriations for the 2008-2009 fiscal year.

19 Section 2. In order to implement Specific Appropriations 6,  
20 7, and 81 through 83 of the 2008-2009 General Appropriations Act,  
21 the calculations of the Florida Education Finance Program for the  
22 2008-2009 fiscal year in the document entitled "Public School  
23 Funding - The Florida Education Finance Program" dated April ,  
24 2008, and filed with the Secretary of the Senate are incorporated  
25 by reference for the purposes of displaying the calculations used  
26 by the Legislature, consistent with the requirements of the  
27 Florida Statutes, in making appropriations for the Florida  
28 Education Finance Program.

29           Section 3. Any section of this act which implements a  
30 specific appropriation or specifically identified proviso  
31 language in the act making appropriations for the 2008-2009  
32 fiscal year is void if the specific appropriation or specifically  
33 identified proviso language is vetoed. Any section of this act  
34 which implements more than one specific appropriation or more  
35 than one portion of specifically identified proviso language in  
36 the act making appropriations for the 2008-2009 fiscal year is  
37 void if all the specific appropriations or portions of  
38 specifically identified proviso language are vetoed.

39           Section 4. If any other act passed in 2008 contains a  
40 provision that is substantively the same as a provision in this  
41 act, but that removes or is otherwise not subject to the future  
42 repeal applied to such provision by this act, the Legislature  
43 intends that the provision in the other act shall take precedence  
44 and shall continue to operate, notwithstanding the future repeal  
45 provided by this act.

46           Section 5. If any provision of this act or its application  
47 to any person or circumstance is held invalid, the invalidity  
48 does not affect other provisions or applications of the act which  
49 can be given effect without the invalid provision or application,  
50 and to this end the provisions of this act are severable.

51           Section 6. Except as otherwise expressly provided in this  
52 act, this act shall take effect July 1, 2008; or, if this act  
53 fails to become law until after that date, it shall take effect  
54 upon becoming a law and shall operate retroactively to July 1,  
55 2008.
