25	political subdivisions, or any municipality by reason of the

29 (b) Except as provided in s. 775.16, a person whose civil 30 rights have been restored shall not be disqualified to practice, 31 pursue, or engage in any occupation, trade, vocation, profession, or business for which a license, permit, or certificate is 32 33 required to be issued by the state, any of its agencies or 34 political subdivisions, or any municipality solely because of a 35 prior conviction for a crime. However, a person whose civil rights have been restored may be denied a license, permit, or 36 37 certification to pursue, practice, or engage in an occupation, 38 trade, vocation, profession, or business by reason of the prior conviction for a crime if the crime was a felony or first degree 39 40 misdemeanor and directly related to the specific occupation, 41 trade, vocation, profession, or business for which the license, 42 permit, or certificate is sought.

43 (c) Notwithstanding any law to the contrary, a person may 44 not be disqualified from receiving a license, permit, or certificate or from obtaining public employment on the grounds 45 46 that a person's civil rights have not been restored. A person is 47 not required to secure the restoration of his or her civil rights 48 or prove that his or her civil rights have been restored in order 49 to receive a license, permit, or certificate or to obtain public 50 employment.

51 (2)(a) This section <u>does</u> shall not <u>apply</u> be applicable to 52 any law enforcement or correctional agency.

(b) This section <u>does</u> shall not <u>apply</u> be applicable to the employment practices of any fire department relating to the hiring of firefighters. An applicant for employment with any fire department <u>who has</u> with a prior felony conviction shall be excluded from employment for a period of 4 years after expiration

of sentence or final release by the Parole Commission unless the applicant, prior to the expiration of the 4-year period, has received a full pardon or has had his or her civil rights restored.

(c) This section <u>does shall</u> not <u>apply</u> be <u>applicable</u> to the
employment practices of any county or municipality relating to
the hiring of personnel for positions deemed to be critical to
security or public safety pursuant to ss. 125.5801 and 166.0442.
