| 18 | governmental entity and a person which requires the governmental |
| 19 | entity to pay the person \$5,000 or more. The term includes an |
| 20 | agreement that would require a total payment of \$5,000 or more if |
| 21 | each term extension that the agreement authorizes were |
| 22 | instituted. |
| 23 | (b) "Expenditure" means a payment that a governmental |
| 24 | entity makes to a person under a contract. |
| 25 | (c) "Governmental entity" means a state agency, a political |
| 26 | subdivision, a corporation created by and acting on behalf of a |
