| 63 | 327.375 Commercial parasailing |
| 64 | (1) This section may be cited as the "Amber May White Act." |
| 65 | (2) A person may not operate or give permission for the |
| 66 | operation of a vessel engaged in commercial parasailing unless |
| 67 | the owner has obtained an annual license from the commission at a |
| 68 | cost of \$50. All license fees collected shall be paid into the |
| 69 | Marine Resources Conservation Trust Fund to recover the |
| 70 | associated costs of regulating commercial parasailing. The |
| 71 | license must be available for inspection when the vessel is |
| 72 | engaged in commercial parasailing. Proof of insurance, as |
| 73 | required in subsection (3), must be provided to the commission |
| 74 | before a license may be issued. |
| 75 | (3) The owner of a vessel engaged in commercial parasailing |

A person conducting a commercial parasailing activity 89 must provide to each rider upon request a copy of the certificate 90 of insurance, including the insurance carrier's name and address 91 and the insurance policy number. 92 (4) A person engaged in commercial parasailing must meet 93 the following requirements: 94 (a) A person may not operate a vessel for commercial 95 parasailing unless it is designed and equipped for towing a 96 person while parasailing and is equipped with a launch platform 97 and powered winch to release and retrieve the towline. (b) A person may not operate a vessel engaged in commercial 98 99 parasailing on the waters of this state unless the person in 100 charge of or in command of the vessel has a current and valid 101 license issued by the United States Coast Guard authorizing that 102 person to engage in carrying passengers for hire. The license 103 must be appropriate for the number of passengers carried and the 104 displacement of the vessel. The license must be carried on the 105 vessel and be available for inspection while commercial 106 parasailing activities are conducted. 107 (c) A person may not operate a vessel for commercial 108 parasailing unless an observer who is 18 years of age or older is 109 present in the vessel at all times to monitor the progress of any 110 airborne parasail rider and parasail equipment. The observer shall be attentive to the parasail rider or riders and equipment, 111 112 and may not have any other duties while the rider or riders are 113 in the water or suspended above the water. 114 (d) A person may not operate any vessel engaged in 115 commercial parasailing unless: 116 1. All riders wear an appropriate floatation device
