I. SUMMARY

This bill re-creates the Administrative Trust Fund, without modification, effective July 1, 2008. The Administrative Trust Fund, FLAIR number 67-2-021, is administered by the Agency for Persons with Disabilities. This fund was created effective July 1, 2005, by chapter 2005-21, Laws of Florida. This bill also repeals the provision for the scheduled termination of the trust fund.

II. SUBSTANTIVE ANALYSIS

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 19(f), Article III of the State Constitution requires that every trust fund be created or recreated by a three-fifths vote of the membership in each house of the Legislature in a separate bill for the sole purpose of creating that trust fund. The Constitution also provides that all newly created trust funds terminate not more than four years after the initial creation unless re-created. The Administrative Trust Fund was created effective July 1, 2005, by chapter 2005-21, Laws of Florida, in section 20.1971, Florida Statutes.

BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

This trust fund is used to support the agency's administration of Medicaid programs and other related purposes.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major source of revenue for this fund is federal matching funds provided for the administration of Medicaid services.

4. TOTAL PROJECTED RECEIPTS INTO THE FUND AND CURRENT YEAR APPROPRIATONS FROM THE FUND:

Total Receipts into this fund in Fiscal Year 2006-07 were \$156,521. Fiscal Year 2007-08 appropriations from the fund total \$224,050.

B. EFFECT OF PROPOSED CHANGES:

The bill re-creates the trust fund without modification and repeals the schedule termination of the trust fund.

III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
