 2           An act relating to trust funds; re-creating the Shared  
 3           County/State Juvenile Detention Trust Fund within the  
 4           Department of Juvenile Justice without modification;  
 5           carrying forward current balances and continuing current  
 6           sources and uses thereof; amending s. 985.6015, F.S.;  
 7           removing the scheduled termination of the trust fund;  
 8           amending s. 985.686, F.S.; providing for the deposit of  
 9           counties' shares of their total costs for juvenile  
 10          detention into the Shared County/State Juvenile Detention  
 11          Trust Fund rather than the Juvenile Justice Grants and  
 12          Donations Trust Fund; providing an effective date.

14   Be It Enacted by the Legislature of the State of Florida:

16           Section 1.   (1) The Shared County/State Juvenile Detention  
 17           Trust Fund within the Department of Juvenile Justice, FLAIR  
 18           number 80-2-685, which is to be terminated pursuant to Section  
 19           19(f), Article III of the State Constitution on July 1, 2009, is  
 20           re-created.

21           (2) All current balances of the trust fund are carried  
 22           forward, and all current sources and uses of the trust fund are  
 23           continued.

24           Section 2.   Section 985.6015, Florida Statutes, is amended  
 25           to read:

26           985.6015   Shared County/State Juvenile Detention Trust  
 27           Fund.--

28 (1) The Shared County/State Juvenile Detention Trust Fund  
 29 is created within the department.

30 (2) The fund is established for use as a depository for  
 31 funds to be used for the costs of predisposition juvenile  
 32 detention. Moneys credited to the trust fund shall consist of  
 33 funds from the counties' share of the costs for predisposition  
 34 juvenile detention.

35 ~~(3) In accordance with s. 19(f)(2), Art. III of the State~~  
 36 ~~Constitution, the Shared County/State Juvenile Detention Trust~~  
 37 ~~Fund shall, unless terminated sooner, be terminated on July 1,~~  
 38 ~~2009. Before its scheduled termination, the trust fund shall be~~  
 39 ~~reviewed as provided in s. 215.3206(1) and (2).~~

40 Section 3. Subsection (6) of section 985.686, Florida  
 41 Statutes, is amended to read:

42 985.686 Shared county and state responsibility for  
 43 juvenile detention.--

44 (6) Each county shall pay to the department for deposit  
 45 into the Shared County/State Juvenile Detention Trust Fund  
 46 ~~Juvenile Justice Grants and Donations Trust Fund~~ its share of  
 47 the county's total costs for juvenile detention, based upon  
 48 calculations published by the department with input from the  
 49 counties.

50 Section 4. This act shall take effect July 1, 2008.
