6 Section 1. Subsection (17) of section 318.18, Florida
7 Statutes, is amended to read:

8 318.18 Amount of penalties.--The penalties required for a
9 noncriminal disposition pursuant to s. 318.14 or a criminal
10 offense listed in s. 318.17 are as follows:

11 (17) In addition to any penalties imposed, a surcharge of
12 \$3 must be paid for all criminal offenses listed in s. 318.17 and
13 for all noncriminal moving traffic violations under chapter 316.
14 Revenue from the surcharge shall be remitted to the Department of
15 Revenue and deposited quarterly into the State Agency Law
16 Enforcement Radio System Trust Fund of the Department of
17 Management Services for the state agency law enforcement radio

 26 | providing technical assistance to state agencies and local law
