 17 Section 1. Subsection (1) of section 15.09, Florida
 18 Statutes, is amended to read:

34 Section 2. Paragraph (m) of subsection (5) of section
 35 267.031, Florida Statutes, is amended, and paragraphs (n)
 36 through (p) of that subsection are redesignated as paragraphs
 37 (m) through (o), respectively, to read:

38 267.031 Division of Historical Resources; powers and

40 (5) It is the responsibility of the division to:

41 ~~(m) Establish regional offices for the purpose of~~

57 contracts for historic preservation; powers and duties.--

58 ~~(5) The Division of Historical Resources in the Department~~
59 ~~of State may contract with the University of West Florida to~~
60 ~~serve as the regional office for the West Florida region of the~~
61 ~~state from the Apalachicola River to the western boundaries of~~
62 ~~the state. In lieu of the establishment of a citizen advisory~~
63 ~~board as required by s. 267.031(5)(m), the University of West~~
64 ~~Florida may use an existing direct support organization of the~~
65 ~~university provided that the membership of the direct support~~
66 ~~organization is representative of the area of the state to be~~
67 ~~served and provides the needed expertise in the area of historic~~
