9 (10) (a) Beginning July 1, 1999, not more than one-fourth of the funds provided for in subsections (1) and (8) in any year 10 shall be reserved annually by a governing board, during the 11 12 development of its annual operating budget, for payments in lieu of taxes for all actual tax losses incurred as a result of 13 14 governing board acquisitions for water management districts 15 pursuant to ss. 259.101, 259.105, 373.470, and this section during any year. Reserved funds not used for payments in lieu of 16 taxes in any year shall revert to the Water Management Lands 17

18 Trust Fund to be used in accordance with the provisions of this 19 section.

20 (e) If property that was subject to ad valorem taxation was 21 acquired by a tax-exempt entity for ultimate conveyance to the 22 state under this chapter, payment in lieu of taxes shall be made 23 for such property based upon the average amount of taxes paid on 24 the property for the 3 years prior to its being removed from the 25 tax rolls. The water management districts shall certify to the 26 Department of Revenue those properties that may be eligible under 27 this provision. Once eligibility has been established, that governmental entity shall receive 10 consecutive annual payments 28 29 for each tax loss until the qualifying governmental entity 30 exceeds the population threshold pursuant to s. 259.032(12)(b). $\tau$ and no further eligibility determination shall be made during 31 32 that period.
