21 Section 2. Subsection (6) of section 322.08, Florida
22 Statutes, is amended to read:

23 322.08 Application for license.--

24 (6) The application form for a driver's license or
25 duplicate thereof shall include language permitting the
26 following:

27 (a) A voluntary contribution of \$5 per applicant, which
28 contribution shall be transferred into the Election Campaign
29 Financing Trust Fund.

30 (b) A voluntary contribution of \$1 per applicant, which
31 contribution shall be deposited into the Florida Organ and Tissue
32 Donor Education and Procurement Trust Fund for organ and tissue
33 donor education and for maintaining the organ and tissue donor
34 registry.

35 (c) A voluntary contribution of \$1 per applicant, which
36 contribution shall be distributed to the Florida Council of the
37 Blind.

38 (d) A voluntary contribution of \$2 per applicant, which
39 shall be distributed to the Hearing Research Institute,
40 Incorporated.

41 (e) A voluntary contribution of \$1 per applicant, which
42 shall be distributed to the Juvenile Diabetes Foundation
43 International.

44 (f) A voluntary contribution of \$1 per applicant, which
45 shall be distributed to the Children's Hearing Help Fund.

 60 contribution of \$1 per applicant, to be quarterly distributed by
 61 the department to Prevent Blindness Florida, a not-for-profit

 63 residents of this state. A statement providing an explanation of
 64 the purpose of the funds shall be included with the application
