The registration license plate is designed to 17 increase nighttime visibility and legibility and shall be at 18 19 least 6 inches wide and not less than 12 inches in length, unless a plate with reduced dimensions is deemed necessary by 20 21 the department to accommodate motorcycles, mopeds, or similar 22 smaller vehicles. Validation stickers shall be treated with a retroreflective material, shall be of such size as specified by 23 24 the department, and shall adhere to the license plate. The registration license plate shall be imprinted with a combination 25 of bold letters and numerals or numerals, not to exceed seven 26 digits, to identify the registration license plate number. Any county may, upon majority vote of the county commission, elect 31 to have the county name removed from the license plates sold in 32 that county. In counties opting to remove the county name, 33 34 license plates with the state motto printed on the bottom and 35 license plates with the words "Sunshine State" printed on the 36 bottom shall both be offered for issuance., except that 37 Apportioned license plates shall have the word "Apportioned" at the bottom and license plates issued for vehicles taxed under s. 38 320.08(3)(d), (4)(m) or (n), (5)(b) or (c), or (14) shall have 39 the word "Restricted" at the bottom.
