 4 registration or renewal to make a voluntary contribution
 5 to Family First; amending s. 322.08, F.S.; allowing an
 6 applicant for a driver's license to make a voluntary
 7 contribution to Family First; providing an effective date.

 9 Be It Enacted by the Legislature of the State of Florida:

 11 Section 1. Paragraph (f) is added to subsection (16) of
 12 section 320.02, Florida Statutes, to read:

13 320.02 Registration required; application for
 14 registration; forms.--

16 (f) The application form for motor vehicle registration
 17 and renewal of registration must include language permitting a
 18 voluntary contribution of \$1 to Family First. Such contributions
 19 must be transferred by the department each month to Family
 20 First, a nonprofit organization.

 22 For the purpose of applying the service charge provided in s.
 23 215.20, contributions received under this subsection are not
 24 income of a revenue nature.

25 Section 2. Subsection (6) of section 322.08, Florida
 26 Statutes, is amended to read:

27 322.08 Application for license.--

28 (6) The application form for a driver's license or

29 duplicate thereof shall include language permitting the
30 following:

31 (a) A voluntary contribution of \$5 per applicant, which
32 contribution shall be transferred into the Election Campaign
33 Financing Trust Fund.

34 (b) A voluntary contribution of \$1 per applicant, which
35 contribution shall be deposited into the Florida Organ and
36 Tissue Donor Education and Procurement Trust Fund for organ and
37 tissue donor education and for maintaining the organ and tissue
38 donor registry.

39 (c) A voluntary contribution of \$1 per applicant, which
40 contribution shall be distributed to the Florida Council of the
41 Blind.

42 (d) A voluntary contribution of \$2 per applicant, which
43 shall be distributed to the Hearing Research Institute,
44 Incorporated.

45 (e) A voluntary contribution of \$1 per applicant, which
46 shall be distributed to the Juvenile Diabetes Foundation
47 International.

48 (f) A voluntary contribution of \$1 per applicant, which
49 shall be distributed to the Children's Hearing Help Fund.

50 (g) A voluntary contribution of \$1 per applicant, which
51 contribution shall be distributed to Family First, a nonprofit
52 organization.

54 A statement providing an explanation of the purpose of the trust
55 funds shall also be included. For the purpose of applying the
56 service charge provided in s. 215.20, contributions received
