HB 7115 2008

A bill to be entitled

An act relating to counterfeiting a payment instrument; amending s. 831.28, F.S.; increasing the penalty for the offense of counterfeiting a payment instrument; amending s. 921.0022, F.S.; conforming the offense severity ranking chart ranking levels to the increased penalty for counterfeiting a payment instrument; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Paragraph (a) of subsection (2) of section 831.28, Florida Statutes, is amended to read:

831.28 Counterfeiting a payment instrument; possessing a counterfeit payment instrument; penalties.--

(2)(a) It is unlawful to counterfeit a payment instrument with the intent to defraud a financial institution, account holder, or any other person or organization or for a person to have any counterfeit payment instrument in such person's possession. Any person who violates this subsection commits a felony of the second third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

Section 2. Paragraphs (c) and (g) of subsection (3) of section 921.0022, Florida Statutes, are amended to read:
