former emergency medical technicians or paramedics certified in compliance with chapter 401, Florida Statutes, the names, home addresses, telephone numbers, and places of employment of the spouses and children of such emergency medical technicians and paramedics, and the names and locations of schools and day care facilities attended by children of such emergency medical technicians and paramedics is a public necessity. This exemption is justified because if such information were not exempt, an emergency medical technician or paramedic or a member or members of his or her family could be harmed or threatened with harm by an individual, or a family member of such individual, who was provided emergency medical care which resulted in a negative outcome. The exemption is further justified because emergency medical technicians and paramedics are subject to the same exposure as law enforcement officers and firefighters, both of which are protected by an exemption from public records requirements for personal identifying and location information pertaining to the law enforcement officers, firefighters, and their families.

Section 3. This act shall take effect July 1, 2008.
