**I. Summary:**

This bill re-creates the Federal Grants Trust Fund within the state courts system without modification, and repeals the provisions that would have terminated the trust fund. This bill amends s. 25.3842, Florida Statutes.

**II. Present Situation:**

Currently, the Federal Grants Trust Fund within the state courts system is scheduled to be terminated on July 1, 2010. Article III, Section 19(f) of the Florida Constitution requires the termination of all state trust funds within four years of their initial creation, unless exempt by the Constitution or operation of law. Funds credited to this trust fund consist of grants and funding from the federal government, and cash advances from other trust funds. This trust fund was created for use as a depository for funds to be used for allowable grant activities funded by restricted program revenues.

The Federal Grants Trust Fund supports operations in the state courts system. For the current year, the legislature has appropriated \$8.5 million from this trust fund.
