 43 WHEREAS, Florida's current budget difficulties require the
 44 state to consider innovative solutions in addressing the long-
 45 term viability of the state's tax structure, and

46 WHEREAS, the state's tax structure should treat individuals
 47 fairly and equitably, imposing similar tax burdens on people in
 48 similar circumstances, and

49 WHEREAS, exemptions to the state's sales tax should serve
 50 an important state interest and should be uniform in the effect
 51 on citizens of the state, and

52 WHEREAS, the Legislature finds that a periodic sunset and
 53 review of all sales tax exemptions will serve to restore
 54 fairness to the state's tax structure, NOW, THEREFORE,

 56 Be It Enacted by the Legislature of the State of Florida:

57
 58 Section 1. Subsection (2) of section 11.903, Florida
 59 Statutes, is amended to read:

60 11.903 Legislative Sunset Review Committees and the Joint
 61 Legislative Sunset Committee.--

62 (2) The Senate and House of Representatives shall appoint
 63 a Joint Legislative Sunset Committee for the purposes of
 64 overseeing the agency review process required by ss. 11.901-
 65 11.920 and the review of exemptions from the tax on sales, use,
 66 and other transactions required by s. 11.9035 and of making
 67 recommendations to the Legislature regarding such reviews.

68 Section 2. Section 11.9035, Florida Statutes, is created
 69 to read:

70 11.9035 Sales and use tax exemption and exclusion
 71 review.--

72 (1) SHORT TITLE.--This section may be cited as the
 73 "Florida Sales Tax Fairness Restoration Act."

74 (2) SALES TAX EXEMPTIONS REVIEW.--In addition to the
 75 review required under ss. 11.901-11.920, the Joint Legislative
 76 Sunset Committee shall conduct comprehensive, periodic reviews
 77 of all exemptions from the general state sales and use tax and
 78 exclusions of sales of services from such taxation as provided
 79 by this section.

80 (3) PROCEDURES.--In addition to other meeting requirements
 81 specified by ss. 11.901-11.920, the committee for each review
 82 cycle shall have its initial meeting no later than September 1,
 83 2009, and thereafter as necessary at the call of the chair at
 84 the time and place designated by the chair. A quorum shall

85 consist of a majority of the committee members from each house.
 86 During the interim between regular sessions, the committee may
 87 conduct its meetings through teleconferences or other similar
 88 means.

89 (4) RULES.--For purposes of this section, the committee
 90 shall be governed by joint rules adopted by the Legislature
 91 pursuant to authority to adopt rules under s. 4, Art. III of the
 92 State Constitution.

93 (5) DEFINITIONS.--As used in this section, the term:

94 (a) "General state sales and use tax" means the sales and
 95 use tax imposed under chapter 212.

96 (b) "Service" means a service within any of the following
 97 service categories under the North American Industry
 98 Classification System (NAICS):

- 99 1. Personal services.
- 100 2. Professional services.
- 101 3. Business services.
- 102 4. Financial services.
- 103 5. Media services.
- 104 6. Entertainment and sports services.
- 105 7. Construction services.
- 106 8. Institutional services.
- 107 9. Transportation services.
- 108 10. Health services.

109 (6) POWERS AND DUTIES.--The committee shall have the power
 110 and duty to conduct a comprehensive review of all current and
 111 future exemptions from the general state sales and use tax and
 112 the exclusion of sales of services from such taxation. The

113 committee shall establish criteria by which each exemption or
114 exclusion shall be evaluated. In developing the evaluation
115 criteria, the committee shall consider the following principles
116 of taxation:

117 (a) Equity.--The Florida tax system should treat
118 individuals equitably. It should impose similar tax burdens on
119 people in similar circumstances and should minimize
120 regressivity.

121 (b) Simplicity, transparency, and compliance.--The Florida
122 tax system should facilitate taxpayer compliance. It should be
123 simple and easy to understand and should provide visibility and
124 awareness of the taxes being paid.

125 (c) Neutrality.--The Florida tax system should affect
126 taxpayers uniformly and consistently. The primary purpose of any
127 tax should be to raise revenue for appropriate governmental
128 functions, rather than to influence business and personal
129 decisions.

130 (d) Stability.--The Florida tax system should produce
131 revenues in a stable and reliable manner that is sufficient to
132 fund appropriate governmental functions and expenditures.

133 (e) Integration.--The Florida tax system should balance
134 the need for integration of federal, state, and local taxation.

135 (f) Public purpose.--Any sales and use tax exemption or
136 exclusion under the Florida tax system should be based upon a
137 determination that the exemption or exclusion promotes an
138 important state interest and should benefit citizens as equally
139 as possible.

140 (7) FINDINGS AND RECOMMENDATIONS.--In conducting its

141 review of each exemption from the general state sales and use
142 tax or the exclusion of the sale of a service from such
143 taxation, the committee shall make findings of fact and
144 recommend whether the exemption should be retained, modified, or
145 repealed or whether the exclusion should be retained or
146 eliminated. Each recommendation must be made by majority vote of
147 the committee members from each house. If a majority vote of the
148 committee members from each house cannot be achieved, the
149 committee must recommend that the exemption or exclusion be
150 repealed. The findings of fact and recommendations of the
151 committee shall be made by reports to the President of the
152 Senate and the Speaker of the House of Representatives.

153 (8) EXEMPTIONS AND EXCLUSIONS REVIEW.--

154 (a) The committee may use its discretion in determining
155 the order in which it reviews the exemptions and exclusions. For
156 the initial review, the committee shall submit, to the President
157 of the Senate and the Speaker of the House of Representatives,
158 its initial report on one-third of the exemptions and exclusions
159 by November 1, 2009, its report on the second one-third of the
160 exemptions and exclusions by March 1, 2010, and its report on
161 the final one-third of the exemptions and exclusions by July 1,
162 2010, with no duplication of exemptions or exclusions from one
163 report to the next. Thereafter, the committee shall review every
164 3 years approximately one-third of the exemptions and exclusions
165 with no duplication of exemptions or exclusions reviewed from
166 one 3-year period to the next 3-year period. The committee shall
167 submit its 3-year period review reports no later than December 1
168 of the year prior to the next regular session after the

169 expiration of the third year of each 3-year review cycle. The
170 committee shall begin a new 9-year review cycle of all
171 exemptions from the general state sales and use tax and all
172 exclusions of sales of services from such taxation every 9 years
173 after the termination of the previous review cycle.

174 (b) Notwithstanding the provisions of this section,
175 exemptions and exclusions for necessities, including, but not
176 limited to, exemptions for general groceries as described in s.
177 212.08(1), exemptions for medical products or supplies as
178 described in s. 212.08(2), health services, residential housing,
179 residential electricity, and home heating fuel, and sales of
180 property or services that the state is prohibited from taxing
181 under the Constitution or laws of the United States may not be
182 subject to review by the committee or repeal in legislation
183 proposed by the committee.

184 (9) LEGISLATION.--At the regular session after submission
185 of each annual report to the Speaker of the House of
186 Representatives and the President of the Senate, the committee
187 shall introduce in both houses of the Legislature bills
188 presenting for reenactment, modification, or repeal those
189 exemptions from the general state sales and use tax or any
190 imposition of such taxation on sales of services that were
191 recommended by the committee in the report submitted immediately
192 prior to the session in which introduced. Each bill introduced
193 must be restricted to a single exemption or the imposition of
194 the tax on a single service and must be submitted to a vote of
195 the members of each house of the Legislature no later than the
196 eighth week of the session in which introduced, unless the

197 substance of the bill has already been voted on by the members
 198 of that house of the Legislature in another bill during that
 199 session and either passed or defeated or the bill has already
 200 been submitted to the members of the other house and has been
 201 defeated.

202 (10) REPEAL.--Any exemption from the state general sales
 203 and use tax or exemption from imposition of such tax on sales of
 204 services, that is not prohibited from review by the committee
 205 under the requirements of paragraph (8) (b) and is not modified
 206 or reenacted by the end of the regular session after any 9-year
 207 review period, stands repealed on July 1 after the end of the
 208 regular session immediately after the 9-year review period.

209 (11) CONSTRUCTION.--This section does not preclude a
 210 legislator from filing for any legislative session a bill
 211 proposing to modify, repeal, or enact any exemption from the
 212 general state sales and use tax or the imposition of such
 213 taxation on the sales of any service.

214 Section 3. Effective July 1, 2012, section 212.08, Florida
 215 Statutes, is amended to read:

216 212.08 Sales, rental, use, consumption, distribution, and
 217 storage tax; specified exemptions.--The sale at retail, the
 218 rental, the use, the consumption, the distribution, and the
 219 storage to be used or consumed in this state of the following
 220 are hereby specifically exempt from the tax imposed by this
 221 chapter.

222 (1) EXEMPTIONS; GENERAL GROCERIES.--

223 (a) Food products for human consumption are exempt from
 224 the tax imposed by this chapter.

225 (b) For the purpose of this chapter, as used in this
 226 subsection, the term "food products" means edible commodities,
 227 whether processed, cooked, raw, canned, or in any other form,
 228 which are generally regarded as food. This includes, but is not
 229 limited to, all of the following:

230 1. Cereals and cereal products, baked goods,
 231 oleomargarine, meat and meat products, fish and seafood
 232 products, frozen foods and dinners, poultry, eggs and egg
 233 products, vegetables and vegetable products, fruit and fruit
 234 products, spices, salt, sugar and sugar products, milk and dairy
 235 products, and products intended to be mixed with milk.

236 2. Natural fruit or vegetable juices or their concentrates
 237 or reconstituted natural concentrated fruit or vegetable juices,
 238 whether frozen or unfrozen, dehydrated, powdered, granulated,
 239 sweetened or unsweetened, seasoned with salt or spice, or
 240 unseasoned; coffee, coffee substitutes, or cocoa; and tea,
 241 unless it is sold in a liquid form.

242 3. Bakery products sold by bakeries, pastry shops, or like
 243 establishments that do not have eating facilities.

244 (c) The exemption provided by this subsection does not
 245 apply:

246 1. When the food products are sold as meals for
 247 consumption on or off the premises of the dealer.

248 2. When the food products are furnished, prepared, or
 249 served for consumption at tables, chairs, or counters or from
 250 trays, glasses, dishes, or other tableware, whether provided by
 251 the dealer or by a person with whom the dealer contracts to
 252 furnish, prepare, or serve food products to others.

253 3. When the food products are ordinarily sold for
254 immediate consumption on the seller's premises or near a
255 location at which parking facilities are provided primarily for
256 the use of patrons in consuming the products purchased at the
257 location, even though such products are sold on a "take out" or
258 "to go" order and are actually packaged or wrapped and taken
259 from the premises of the dealer.

260 4. To sandwiches sold ready for immediate consumption on
261 or off the seller's premises.

262 5. When the food products are sold ready for immediate
263 consumption within a place, the entrance to which is subject to
264 an admission charge.

265 6. When the food products are sold as hot prepared food
266 products.

267 7. To soft drinks, which include, but are not limited to,
268 any nonalcoholic beverage, any preparation or beverage commonly
269 referred to as a "soft drink," or any noncarbonated drink made
270 from milk derivatives or tea, when sold in cans or similar
271 containers.

272 8. To ice cream, frozen yogurt, and similar frozen dairy
273 or nondairy products in cones, small cups, or pints, popsicles,
274 frozen fruit bars, or other novelty items, whether or not sold
275 separately.

276 9. To food prepared, whether on or off the premises, and
277 sold for immediate consumption. This does not apply to food
278 prepared off the premises and sold in the original sealed
279 container, or the slicing of products into smaller portions.

280 10. When the food products are sold through a vending
 281 machine, pushcart, motor vehicle, or any other form of vehicle.

282 11. To candy and any similar product regarded as candy or
 283 confection, based on its normal use, as indicated on the label
 284 or advertising thereof.

285 12. To bakery products sold by bakeries, pastry shops, or
 286 like establishments that have eating facilities, except when
 287 sold for consumption off the seller's premises.

288 13. When food products are served, prepared, or sold in or
 289 by restaurants, lunch counters, cafeterias, hotels, taverns, or
 290 other like places of business.

291 (d) As used in this subsection, the term:

292 1. "For consumption off the seller's premises" means that
 293 the food or drink is intended by the customer to be consumed at
 294 a place away from the dealer's premises.

295 2. "For consumption on the seller's premises" means that
 296 the food or drink sold may be immediately consumed on the
 297 premises where the dealer conducts his or her business. In
 298 determining whether an item of food is sold for immediate
 299 consumption, there shall be considered the customary consumption
 300 practices prevailing at the selling facility.

301 3. "Premises" shall be construed broadly, and means, but
 302 is not limited to, the lobby, aisle, or auditorium of a theater;
 303 the seating, aisle, or parking area of an arena, rink, or
 304 stadium; or the parking area of a drive-in or outdoor theater.
 305 The premises of a caterer with respect to catered meals or
 306 beverages shall be the place where such meals or beverages are
 307 served.

308 4. "Hot prepared food products" means those products,
309 items, or components which have been prepared for sale in a
310 heated condition and which are sold at any temperature that is
311 higher than the air temperature of the room or place where they
312 are sold. "Hot prepared food products," for the purposes of this
313 subsection, includes a combination of hot and cold food items or
314 components where a single price has been established for the
315 combination and the food products are sold in such combination,
316 such as a hot meal, a hot specialty dish or serving, or a hot
317 sandwich or hot pizza, including cold components or side items.

318 (e)1. Food or drinks not exempt under paragraphs (a), (b),
319 (c), and (d) shall be exempt, notwithstanding those paragraphs,
320 when purchased with food coupons or Special Supplemental Food
321 Program for Women, Infants, and Children vouchers issued under
322 authority of federal law.

323 2. This paragraph is effective only while federal law
324 prohibits a state's participation in the federal food coupon
325 program or Special Supplemental Food Program for Women, Infants,
326 and Children if there is an official determination that state or
327 local sales taxes are collected within that state on purchases
328 of food or drinks with such coupons.

329 3. This paragraph shall not apply to any food or drinks on
330 which federal law shall permit sales taxes without penalty, such
331 as termination of the state's participation.

332 (2) EXEMPTIONS; MEDICAL.--

333 (a) There shall be exempt from the tax imposed by this
334 chapter any medical products and supplies or medicine dispensed
335 according to an individual prescription or prescriptions written

336 by a prescriber authorized by law to prescribe medicinal drugs;
337 hypodermic needles; hypodermic syringes; chemical compounds and
338 test kits used for the diagnosis or treatment of human disease,
339 illness, or injury; and common household remedies recommended
340 and generally sold for internal or external use in the cure,
341 mitigation, treatment, or prevention of illness or disease in
342 human beings, but not including cosmetics or toilet articles,
343 notwithstanding the presence of medicinal ingredients therein,
344 according to a list prescribed and approved by the Department of
345 Health, which list shall be certified to the Department of
346 Revenue from time to time and included in the rules promulgated
347 by the Department of Revenue. There shall also be exempt from
348 the tax imposed by this chapter artificial eyes and limbs;
349 orthopedic shoes; prescription eyeglasses and items incidental
350 thereto or which become a part thereof; dentures; hearing aids;
351 crutches; prosthetic and orthopedic appliances; and funerals. In
352 addition, any items intended for one-time use which transfer
353 essential optical characteristics to contact lenses shall be
354 exempt from the tax imposed by this chapter; however, this
355 exemption shall apply only after \$100,000 of the tax imposed by
356 this chapter on such items has been paid in any calendar year by
357 a taxpayer who claims the exemption in such year. Funeral
358 directors shall pay tax on all tangible personal property used
359 by them in their business.

360 (b) For the purposes of this subsection:

361 1. "Prosthetic and orthopedic appliances" means any
362 apparatus, instrument, device, or equipment used to replace or
363 substitute for any missing part of the body, to alleviate the

364 malfunction of any part of the body, or to assist any disabled
365 person in leading a normal life by facilitating such person's
366 mobility. Such apparatus, instrument, device, or equipment shall
367 be exempted according to an individual prescription or
368 prescriptions written by a physician licensed under chapter 458,
369 chapter 459, chapter 460, chapter 461, or chapter 466, or
370 according to a list prescribed and approved by the Department of
371 Health, which list shall be certified to the Department of
372 Revenue from time to time and included in the rules promulgated
373 by the Department of Revenue.

374 2. "Cosmetics" means articles intended to be rubbed,
375 poured, sprinkled, or sprayed on, introduced into, or otherwise
376 applied to the human body for cleansing, beautifying, promoting
377 attractiveness, or altering the appearance and also means
378 articles intended for use as a compound of any such articles,
379 including, but not limited to, cold creams, suntan lotions,
380 makeup, and body lotions.

381 3. "Toilet articles" means any article advertised or held
382 out for sale for grooming purposes and those articles that are
383 customarily used for grooming purposes, regardless of the name
384 by which they may be known, including, but not limited to, soap,
385 toothpaste, hair spray, shaving products, colognes, perfumes,
386 shampoo, deodorant, and mouthwash.

387 4. "Prescription" includes any order for drugs or
388 medicinal supplies written or transmitted by any means of
389 communication by a duly licensed practitioner authorized by the
390 laws of the state to prescribe such drugs or medicinal supplies
391 and intended to be dispensed by a pharmacist. The term also

392 includes an orally transmitted order by the lawfully designated
393 agent of such practitioner. The term also includes an order
394 written or transmitted by a practitioner licensed to practice in
395 a jurisdiction other than this state, but only if the pharmacist
396 called upon to dispense such order determines, in the exercise
397 of his or her professional judgment, that the order is valid and
398 necessary for the treatment of a chronic or recurrent illness.
399 The term also includes a pharmacist's order for a product
400 selected from the formulary created pursuant to s. 465.186. A
401 prescription may be retained in written form, or the pharmacist
402 may cause it to be recorded in a data processing system,
403 provided that such order can be produced in printed form upon
404 lawful request.

405 (c) Chlorine shall not be exempt from the tax imposed by
406 this chapter when used for the treatment of water in swimming
407 pools.

408 (d) Lithotripters are exempt.

409 (e) Human organs are exempt.

410 (f) Sales of drugs to or by physicians, dentists,
411 veterinarians, and hospitals in connection with medical
412 treatment are exempt.

413 (g) Medical products and supplies used in the cure,
414 mitigation, alleviation, prevention, or treatment of injury,
415 disease, or incapacity which are temporarily or permanently
416 incorporated into a patient or client by a practitioner of the
417 healing arts licensed in the state are exempt.

418 (h) The purchase by a veterinarian of commonly recognized
419 substances possessing curative or remedial properties which are

420 ordered and dispensed as treatment for a diagnosed health
 421 disorder by or on the prescription of a duly licensed
 422 veterinarian, and which are applied to or consumed by animals
 423 for alleviation of pain or the cure or prevention of sickness,
 424 disease, or suffering are exempt. Also exempt are the purchase
 425 by a veterinarian of antiseptics, absorbent cotton, gauze for
 426 bandages, lotions, vitamins, and worm remedies.

427 (i) X-ray opaques, also known as opaque drugs and
 428 radiopaque, such as the various opaque dyes and barium sulphate,
 429 when used in connection with medical X rays for treatment of
 430 bodies of humans and animals, are exempt.

431 (j) Parts, special attachments, special lettering, and
 432 other like items that are added to or attached to tangible
 433 personal property so that a handicapped person can use them are
 434 exempt when such items are purchased by a person pursuant to an
 435 individual prescription.

436 (k) This subsection shall be strictly construed and
 437 enforced.

438 ~~(3) EXEMPTIONS; CERTAIN FARM EQUIPMENT.--There shall be no~~
 439 ~~tax on the sale, rental, lease, use, consumption, or storage for~~
 440 ~~use in this state of power farm equipment used exclusively on a~~
