Section 1. Paragraph (d) of subsection (4) of section 119.071, Florida Statutes, is amended, and paragraph (i) is added to subsection (5) of that section, to read:

119.071 General exemptions from inspection or copying of public records.—

- (4) AGENCY PERSONNEL INFORMATION. -
- (d) 1.a. The home addresses, telephone numbers, social

security numbers, and photographs of active or former law enforcement personnel, including correctional and correctional probation officers, personnel of the Department of Children and Family Services whose duties include the investigation of abuse, neglect, exploitation, fraud, theft, or other criminal activities, personnel of the Department of Health whose duties are to support the investigation of child abuse or neglect, and personnel of the Department of Revenue or local governments whose responsibilities include revenue collection and enforcement or child support enforcement; the home addresses, telephone numbers, social security numbers, photographs, and places of employment of the spouses and children of such personnel; and the names and locations of schools and day care facilities attended by the children of such personnel are exempt from s. 119.07(1).

2. Identification and location information held by an agency is exempt from s. 119.07(1) and s. 24(a), Art. I of the State Constitution if such attorney, judge, or magistrate:

- <u>a. Submits to an agency that has custody of the</u>
 identification and location information a written request to
 exempt such information from public disclosure; and
- b. Submits to the agency a written statement that such attorney, judge, or magistrate has made reasonable efforts to protect such information from being accessible through other means available to the public.

Section 2. This act shall take effect October 1, 2009.
