Be It Enacted by the Legislature of the State of Florida:

Section 1. <u>Florida Council on Cardiovascular Disease and</u> Stroke.--

- (1) DEFINITIONS.--As used in this section, the term:
- (a) "Cardiovascular disease" means the group of diseases
  that involve the heart and blood vessels and that are the result
  of complex interactions between multiple inherited traits and
  environmental factors.
- (b) "Council" means the Florida Council on Cardiovascular Disease and Stroke.
- (c) "Managed care entity" means a health maintenance organization or a prepaid health clinic certified under chapter 641, a prepaid health plan authorized under s. 409.912, Florida Statutes, or an exclusive provider organization certified under s. 627.6472, Florida Statutes.
  - (2) APPOINTMENT OF COUNCIL; TERMS OF MEMBERS.--
- (a) The Florida Council on Cardiovascular Disease and Stroke is composed of 13 members, including a chairperson, who shall be appointed by the Governor and who are subject to confirmation by the Senate, as follows:
- 1. A licensed physician whose area of specialization is
  cardiology;
- 2. A licensed physician whose area of specialization is neurology to treat stroke;
- 3. A licensed physician who is employed in a primary care setting;
- 4. A licensed physician whose area of specialization is emergency medicine and who serves as an emergency services

57 medical director.

- 5. A registered nurse whose area of specialization is quality improvement practices for cardiovascular disease and stroke;
  - 6. A registered and licensed dietitian;
  - 7. A pharmacist who is licensed in this state;
- 8. Two persons who have experience and training in public health policy, research, or practice;
- 9. Two consumer members, with special consideration given to persons who are active participants in the Florida affiliates of the American Heart Association or American Stroke Association and who work in a managed care entity or in a hospital or rehabilitation setting; and
- 10. Two members of the public who provide care for persons who have cardiovascular disease or are at risk of a stroke or who have suffered from cardiovascular disease or stroke.
- (b) In appointing members under paragraph (a), the

  Governor shall attempt to appoint female members and members of

  different minority groups, including African Americans, Hispanic

  Americans, Native Americans, and Asian Americans. The Governor

  shall fill any vacancies for the remainder of the unexpired term

  in the same manner as the original appointment.
- (c) Members of the council shall be appointed to staggered 4-year terms, with the terms of three or four of the members expiring February 1 of each odd-numbered year.
- (d) A majority of the members of the council constitutes a quorum, and an affirmative vote of a majority of the members is necessary to take action.

(e) The council shall meet quarterly or at the call of the chairperson.

- (f) The Department of Health shall provide staff and administrative support for the council.
- (g) Members of the council shall serve without compensation, but are entitled to reimbursement for travel and per diem expenses incurred in the performance of their duties in accordance with s. 112.061, Florida Statutes.
  - (3) POWERS AND DUTIES OF THE COUNCIL. --

- (a) The council shall develop an effective and resourceefficient plan to reduce the morbidity, mortality, and economic burden of cardiovascular disease and stroke in this state. The council shall:
- 1. Conduct health education, public awareness, and community outreach activities that relate to primary and secondary prevention of cardiovascular disease and stroke;
- 2. Promote, enhance, and coordinate health education, public awareness, and community outreach activities that relate to primary and secondary prevention of cardiovascular disease and stroke and that are provided by private and other public organizations;
- 3. Coordinate activities with other entities that are concerned with medical conditions that are similar to cardiovascular disease and stroke or that have similar risk factors;
- 4. Identify for health care providers, employers, schools, community health centers, and other groups the benefits of encouraging treatment and primary and secondary prevention,

promote public awareness of cardiovascular disease and stroke,
and recognize innovative and effective programs that achieve the
objectives of improved treatment, prevention, and public
awareness;

- 5. Provide guidance regarding the roles and responsibilities of government agencies, health care providers, employers, third-party payers, patients, and families of patients in the treatment, primary and secondary prevention, and public awareness of cardiovascular disease and stroke;
- 6. Improve access to treatment for and primary and secondary prevention of cardiovascular disease and stroke through public awareness programs, including access for uninsured individuals and individuals living in rural or underserved areas;
- 7. Assist communities in developing comprehensive local programs for the prevention of cardiovascular disease and stroke;
- 8. Assist the Department of Education and local school districts in promoting a public school curriculum that includes physical, nutritional, and health education relating to the prevention of cardiovascular disease and stroke;
- 9. Establish appropriate forums, programs, or initiatives that are designed to educate the public regarding the effect of heart disease and stroke on women's health, with an emphasis on preventive health and healthy lifestyles;
- 10. Evaluate and enhance the implementation and effectiveness of the program developed under this section; and
  - 11. Advise the Legislature on legislation that is needed

to develop further and maintain a statewide system of quality education services for all persons who have cardiovascular disease or who have suffered from or are at risk for stroke. The council may develop and submit legislation to the Legislature or comment on pending legislation that affects persons who have cardiovascular disease or who have suffered from or are at risk for stroke.

- (b) By January 15, 2010, the council shall make written recommendations for performing its duties under this section to the Department of Health, the Governor, the President of the Senate, and the Speaker of the House of Representatives.
- (c) By January 15, 2011, and each January 15 thereafter, the council shall report to the Governor, the President of the Senate, and the Speaker of the House of Representatives on the activities of the council, accounting for all funds received and disbursed by or for the council during the preceding fiscal year.
- (4) DATABASE OF CLINICAL RESOURCES. -- The council shall review available clinical resources and shall develop a database of recommendations for appropriate care and treatment of patients who have cardiovascular disease or patients who have suffered from or are at risk for stroke. The council shall make the database accessible to the public.
  - (5) CARDIOVASCULAR DISEASE AND STROKE DATABASE.--
- (a) The council shall collect and analyze information related to cardiovascular disease and stroke at the state level and regional level and, to the extent feasible, at the local level. The council shall obtain the information from federal and

- 2. Morbidity and mortality rates for cardiovascular disease and stroke; and
- 3. Community indicators relevant to cardiovascular disease and stroke.
- (b) In compiling the database, the council may use information available from other sources, such as the Behavioral Risk Factor Surveillance System established by the Centers for Disease Control and Prevention, reports of data from hospital discharges, and information included in death certificates.
- Section 2. This act shall take effect July 1, 2009.
