A bill to be entitled

An act relating to women's health; requiring the Department of Health to create a pilot program in Pasco, Duval, and Miami-Dade Counties to provide health screening for certain women; prescribing services; requiring periodic assessment of participants in the program; requiring the department to submit a report to the Legislature; providing for expiration of the program; providing an appropriation; providing an effective date.

WHEREAS, heart disease, stroke, and other forms of cardiovascular disease are the number one cause of death for women each year, and

WHEREAS, cardiovascular disease kills more women annually than the next five leading causes of death combined, which include all forms of cancer, chronic lower respiratory diseases, Alzheimer's disease, diabetes, and accidents, and

WHEREAS, despite the statistics, many patients and health care providers alike tend to think of heart disease as a disease that primarily afflicts men, and

WHEREAS, in February 2004, the American Heart Association began the vigorous "Go Red for Women" public awareness campaign and a survey conducted in 2007 by the American Heart Association found that 43 percent of women are still not aware that heart disease is the leading cause of death among women, and

WHEREAS, the WISEWOMAN program, administered by the Centers for Disease Control and Prevention, provides low-income, underinsured, or uninsured women between 40 and 64 years of age

with chronic disease risk factor screening, lifestyle intervention, and referral services in an effort to prevent cardiovascular disease and promote healthy lifestyles, and

WHEREAS, WISEWOMAN programs provide standard preventive services, including blood pressure and cholesterol testing and lifestyle programs targeting poor nutrition, physical inactivity, and smoking, and

WHEREAS, Florida is currently not participating in the WISEWOMAN program due to a lack of federal funding, and

WHEREAS, the best chance for women in this state to reduce their mortality rates due to cardiovascular disease is through education and prevention, NOW, THEREFORE,

Be It Enacted by the Legislature of the State of Florida:

## Section 1. <u>Cardiovascular screening and risk-reduction</u> pilot program.--

- (1) The Department of Health shall develop a cardiovascular disease screening and lifestyle intervention pilot program in Pasco, Duval, and Miami-Dade Counties for low-income, underinsured, and uninsured women between 40 and 64 years of age, inclusive, at risk for heart disease, diabetes, and stroke.
- (2) The department shall develop the program based on the federal WISEWOMAN program administered by the Centers for Disease Control and Prevention. The pilot program shall employ specified measures to gauge the impact and outcome of the program. These measures shall include a list of the educational

materials being distributed, the number of followup visits per woman, an evaluation of the use of progress markers to reduce risk factors, and a research and evaluation component.

- (3) The department shall prepare an annual report and submit it to the Legislature by January 31 of each year. The annual report shall compare the cardiovascular health of women in the pilot program to available data on the cardiovascular health of women nationally. The report shall include a fiscal analysis and a recommendation outlining the benefits and costs of expanding the pilot program throughout the state after the program has been in existence for 3 years. The pilot program shall expire July 1, 2012.
- Section 2. The sum of \$500,000 is appropriated from the funds collected under s. 210.02, Florida Statutes, to the Department of Health to implement the pilot program created under section 1.
  - Section 3. This act shall take effect July 1, 2009.
