28	(c) The efficacy of the vaccine.
29	(d) Risks associated with the disease that the vaccination

31	(e) Options that are available with regard to the
32	administration of the vaccination, including the timing or
33	combination of multiple vaccinations.
34	(2) The Department of Health shall develop and provide to
35	each health care provider who is licensed in this state and who,
36	as a part of his or her scope of practice, administers childhood
37	vaccinations a standardized form indicating that the health care
38	provider has fulfilled the requirements in subsection (1). The
39	form shall be kept with the minor's permanent medical record.
40	The health care provider may not vaccinate a minor until after
