10 (8) (a) When the owner of a vehicle transfers a  
11 registration license plate to a replacement or substitute  
12 vehicle acquired from a motor vehicle dealer licensed under this  
13 chapter, the dealer shall timely provide to the department, via  
14 an electronic system administered by the department for this  
15 purpose, information regarding the transfer which is required by  
16 the department. The dealer shall also give the owner written

17 notice documenting the transfer if the dealer cannot timely  
18 provide the required transfer information to the department due  
19 to system or connectivity problems. The dealer shall maintain  
20 all records required by the department which must be open to  
21 inspection by the department or its agents during reasonable  
22 business hours. The dealer may charge the vehicle owner a fee to  
23 comply with this subsection. The department may charge a fee of  
24 \$2 for each transfer in addition to any other fee imposed by  
25 law.

26 (b) A dealer is not required to comply with paragraph (a)  
27 if the department's records are otherwise modified on the date  
28 of transfer to reflect that the transfer has occurred.

29 (c) The department has authority to adopt rules pursuant  
30 to ss. 120.536(1) and 120.54 to administer this subsection.
