(13) Effective July 1, 2011, in addition to the requirements of subsections (10) and (11) and notwithstanding any specific authority provided in s. 320.08058 , an organization or entity receiving annual use fee revenue from the sale of a specialty license plate may use no more than a total of 20 percent of the revenues for administrative, marketing, and promotion costs, including annual audit and compliance affidavit costs.
(14) Notwithstanding any other provision of this chapter, no annual use fee revenue derived from the sale of a specialty license plate, or the interest thereon, shall be expended on projects or programs outside this state.

Section 2. Paragraphs (h) and (i) are added to subsection (15) of section 320.02, Florida Statutes, to read:
320.02 Registration required; application for registration; forms.-
(15)
(h) The application form for motor vehicle registration and renewal of registration must include language permitting a voluntary contribution of $\$ 5$ to the Autism License Plate Fund

administered by Achievement and Rehabilitation Centers, Inc. Except as provided in s. $320.08058(69)(d)$, such contributions must be distributed by the department each month to the Autism License Plate Fund administered by Achievement and Rehabilitation Centers, Inc., to be used as provided in s. 320.08058 (69).
(i) The application form for motor vehicle registration and renewal of registration must include language permitting a voluntary contribution of $\$ 1$ to Ronald McDonald Houses of Florida. Such contributions must be distributed by the department each month to Ronald McDonald House Charities Tampa Bay, Inc., a not-for-profit organization.

For the purpose of applying the service charge provided in s. 215.20, contributions received under this subsection are not income of a revenue nature.

Section 3. Section 320.0706, Florida Statutes, is amended to read:
320.0706 Display of license plates on trucks.-The owner of any commercial truck of gross vehicle weight of 26,001 pounds or more shall display the registration license plate on both the front and rear of the truck in conformance with all the requirements of s. 316.605 that do not conflict with this section. The owner of a dump truck may place the rear license plate on the gate no higher than 60 inches to allow for better visibility. However, the owner of a truck tractor shall be required to display the registration license plate only on the front of such vehicle. The owner of any wrecker issued a regular wrecker license plate shall display the license plate only on

the front of the vehicle. The owner of any wrecker issued gross vehicle weight wrecker license plates shall display the license plates on both the front and rear of the vehicle in conformance with the requirements of s. 316.605 that do not conflict with this section. A violation of this section is a noncriminal traffic infraction, punishable as a moving violation as provided in chapter 318.

Section 4. Subsection (6) of section 322.08, Florida Statutes, is amended to read:
322.08 Application for license.-
(6) The application form for a driver's license or duplicate thereof shall include language permitting the following:
(a) A voluntary contribution of $\$ 1$ per applicant, which contribution shall be deposited into the Health Care Trust Fund for organ and tissue donor education and for maintaining the organ and tissue donor registry.
(b) A voluntary contribution of $\$ 1$ per applicant, which contribution shall be distributed to the Florida Council of the Blind.
(c) A voluntary contribution of $\$ 2$ per applicant, which shall be distributed to the Hearing Research Institute, Incorporated.
(d) A voluntary contribution of $\$ 1$ per applicant, which shall be distributed to the Juvenile Diabetes Foundation International.
(e) A voluntary contribution of $\$ 1$ per applicant, which shall be distributed to the Children's Hearing Help Fund.
(f) A voluntary contribution of $\$ 1$ per applicant, which
shall be distributed to Family First, a nonprofit organization. (g) A voluntary contribution of $\$ 5$ per applicant, which, except as provided in s. 320.08058(69)(d), shall be distributed to the Autism License Plate Fund administered by Achievement and Rehabilitation Centers, Inc., to be used as provided in s. 320.08058 (69).

A statement providing an explanation of the purpose of the trust funds shall also be included. For the purpose of applying the service charge provided in s. 215.20, contributions received under paragraphs (b), (c), (d), (e), (f), and (g) and under s. 322.18(9)(a) are not income of a revenue nature.
