17 the social security number. If the applicant provides the  
18 necessary evidence, the supervisor shall place the applicant's  
19 name on the registration rolls as an active voter. If the  
20 applicant has not provided the necessary evidence or the number  
21 has not otherwise been verified before election day prior to the  
22 applicant presenting himself or herself to vote, the applicant  
23 shall be provided a provisional ballot. The provisional ballot  
24 shall be counted only if the number is verified by the end of  
25 the canvassing period or if the applicant presents evidence to  
26 the supervisor of elections sufficient to verify the  
27 authenticity of the applicant's driver's license number, Florida  
28 identification card number, United States passport number, or  
29 last four digits of the social security number no later than 5  
30 p.m. of the second day following the election.
