9 Section 1. Paragraph (d) of subsection (1) and paragraph
 10 (d) of subsection (2) of section 560.143, Florida Statutes, are
 11 amended to read:

12 560.143 Fees.--

13 (1) LICENSE APPLICATION FEES.--The applicable non-
 14 refundable fees must accompany an application for licensure:

15 (d) For each location ~~appointment~~ of an authorized
 16 vendor....\$38.

17 (2) LICENSE RENEWAL FEES.--The applicable non-refundable
 18 license renewal fees must accompany a renewal of licensure:

19 (d) For each location ~~appointment~~ of an authorized
 20 vendor....\$38.

21 Section 2. Subsection (1) of section 560.2085, Florida
 22 Statutes, is amended to read:

23 560.2085 Authorized vendors.--A licensee under this part
 24 shall:

25 (1) Within 60 days after an authorized vendor commences
 26 business, file with the office such information as prescribed by
 27 rule together with the nonrefundable location ~~appointment~~ fee as

29 | are also terminated within the 60-day period.
