SUMMARY ANALYSIS

The South Indian River Water Control District is an independent special district located in Palm Beach County. The district is governed by a five member board of supervisors. The district has the authority to assess water control and maintenance taxes and special assessments. However, the district only levies non ad-valorem assessments.

HB 743 adds approximately 17.21 acres to the district upon the request of the landowner so that he may receive district flood control services.

I. SUBSTANTIVE ANALYSIS

A. EFFECT OF PROPOSED CHANGES:

Current Situation

The South Indian River Water Control District is an independent special district located in Palm Beach County. The district was created by decree of the Circuit Court of the Fifteenth Judicial Circuit on July 3, 1923. All special acts relating to the district were codified by ch. 2001-313, L.O.F. The district is governed by a five member board of supervisors elected on a one-acre, one-vote basis by the landowners in the district. The district has the authority: to assess water control and maintenance taxes and special assessments, and issue bonds. However, the district only levies non ad-valorem assessments.

District Boundary Modification

Section 298.301, F.S., provides that when a water control district is created, or its authorities or boundaries amended, by special act, lands may be added to or deleted only through legislative modification of the special act.

Effect of Proposed Changes

HB 743 adds approximately 17.21 acres to the district upon the request of the landowner so that he may receive district flood control services.
