39 (e) A voluntary contribution of \$1 per applicant, which

43 (g) A voluntary contribution of \$1 per applicant, to Stop  
44 Heart Disease, which shall be distributed to the Florida Heart  
45 Research Institute, a nonprofit organization.

46 (h) A voluntary contribution of \$1 to Ronald McDonald  
47 House. Such contributions must be transferred by the department  
48 each month to Ronald McDonald House Charities of Tampa Bay, Inc.

50 A statement providing an explanation of the purpose of the trust  
51 funds shall also be included. For the purpose of applying the  
52 service charge provided in s. 215.20, contributions received  
53 under paragraphs (b), (c), (d), (e), (f), ~~and (g)~~, and (h) and  
54 under s. 322.18(9) are not income of a revenue nature.
