Senate Amendment (with title amendment)

Delete everything after the enacting clause and insert:

Section 1. Paragraphs (i), (j), and (k) are added to subsection (15) of section 320.02, Florida Statutes, to read:

320.02 Registration required; application for registration; forms.-

(15)

(i) The application form for motor vehicle registration and renewal of registration must include language permitting a voluntary contribution of \$1 to Blind Babies and Blind Youth

13 Services. Such contributions shall be transferred by the
14 department each month to the Florida Association of Agencies
15 Serving the Blind, Inc., a not-for-profit organization.

16 (j) The application form for motor vehicle registration and
17 renewal of registration must include language permitting a

19 developmental disabilities. Such contributions shall be
20 transferred by the department to The Arc of Florida to be used
21 by that organization for programs and services in this state for
22 persons with developmental disabilities.

43 contribution shall be distributed to the Florida Council of the

45 (c) A voluntary contribution of \$2 per applicant, which
46 shall be distributed to the Hearing Research Institute,
47 Incorporated.

48 (d) A voluntary contribution of \$1 per applicant, which
49 shall be distributed to the Juvenile Diabetes Foundation
50 International.

51 (e) A voluntary contribution of \$1 per applicant, which
52 shall be distributed to the Children's Hearing Help Fund.

53 (f) A voluntary contribution of \$1 per applicant, which
54 shall be distributed to Family First, a nonprofit organization.

55 (g) A voluntary contribution of \$1 per applicant, to Stop
56 Heart Disease, which shall be distributed to the Florida Heart
57 Research Institute, a nonprofit organization.

58 (h) A voluntary contribution of \$1 per applicant to Senior
59 Vision Services, which shall be distributed to the Florida
60 Association of Agencies Serving the Blind, Inc., a not-for-
61 profit organization.

62 (i) A voluntary contribution of \$1 per applicant for
63 services for persons with developmental disabilities, which
64 shall be distributed to The Arc of Florida.

65 (j) A voluntary contribution of \$1 to the Ronald McDonald
66 House, which shall be distributed each month to Ronald McDonald
67 House Charities of Tampa Bay, Inc.
