necessary to confirm the identity of the sexual predator, including a set of fingerprints.

- (q)1. Each time a sexual predator's driver's license or identification card is subject to renewal, and, without regard to the status of the predator's driver's license or identification card, within 48 hours after any change of the predator's residence or change in the predator's name by reason of marriage or other legal process, the predator shall report in person to a driver's license office and shall be subject to the requirements specified in paragraph (f). The Department of Highway Safety and Motor Vehicles shall forward to the department and to the Department of Corrections all photographs and information provided by sexual predators. Notwithstanding the restrictions set forth in s. 322.142, the Department of Highway Safety and Motor Vehicles is authorized to release a reproduction of a color-photograph or digital-image license to the Department of Law Enforcement for purposes of public notification of sexual predators as provided in this section.
- 2. The sheriff shall promptly provide to the department the information received from the sexual predator. - Law enforcement agencies must inform members of the community and the public of a sexual predator's presence. Upon notification of the presence of a sexual predator, the sheriff of the county or the chief of police of the municipality where the sexual predator establishes or maintains a permanent or temporary residence shall notify members of the community and the public of the presence of the sexual predator in a manner deemed appropriate by the sheriff or the chief of police. Within 48 hours after receiving notification of the presence of a sexual predator, the sheriff of the county or the chief of police of the municipality where the sexual predator temporarily or permanently resides shall notify each licensed child care facility day care center, elementary school, middle school, and high school within a 1-mile radius of the temporary or permanent residence of the sexual predator of the presence of the sexual predator. Information provided to members of the community and the public regarding a sexual predator must include:
  - 1. The name of the sexual predator;
- 2. A description of the sexual predator, including a photograph;
- 3. The sexual predator's current <u>permanent</u>, <u>temporary</u>, <u>and transient addresses</u>, <u>and descriptions of registered locations</u>

  <u>that have no specific street</u> address, including the name of the county or municipality if known;
- 4. The circumstances of the sexual predator's offense or offenses; and
- 5. Whether the victim of the sexual predator's offense or offenses was, at the time of the offense, a minor or an adult.

- 508 (8) VERIFICATION.—The department and the Department of 509 Corrections shall implement a system for verifying the addresses of sexual predators. The system must be consistent with the 510 511 provisions of the federal Adam Walsh Child Protection and Safety 512 Act of 2006 and any other federal standards applicable to such 513 verification or required to be met as a condition for the 514 receipt of federal funds by the state. The court may approve supervised contact with a child under the age of 18 if the approval is based upon a recommendation for contact issued by a qualified practitioner who is basing the recommendation on a risk assessment. Further, the sex offender must be currently enrolled in or have successfully completed a sex offender therapy program. The court may not grant supervised contact with a child if the contact is not recommended by a qualified practitioner and may deny supervised contact with a child at any time. When considering whether to approve supervised contact with a child, the court must review and consider the following:
- A risk assessment completed by a qualified practitioner. The qualified practitioner must prepare a written report that must include the findings of the assessment and address each of the following components:
  - The sex offender's current legal status; a.
- The sex offender's history of adult charges with b. apparent sexual motivation;
- The sex offender's history of adult charges without apparent sexual motivation;
- The sex offender's history of juvenile charges, whenever available;
- The sex offender's offender treatment history, 1595 including consultations with the sex offender's treating, or most recent treating, therapist;

- f. The sex offender's current mental status;
  - g. The sex offender's mental health and substance abuse treatment history as provided by the Department of Corrections;
  - h. The sex offender's personal, social, educational, and
    work history;
  - i. The results of current psychological testing of the sex offender if determined necessary by the qualified practitioner;
  - j. A description of the proposed contact, including the location, frequency, duration, and supervisory arrangement;
  - k. The child's preference and relative comfort level with the proposed contact, when age appropriate;
  - 1. The parent's or legal guardian's preference regarding the proposed contact; and
  - m. The qualified practitioner's opinion, along with the basis for that opinion, as to whether the proposed contact would likely pose significant risk of emotional or physical harm to the child.

The written report of the assessment must be given to the court;

- 2. A recommendation made as a part of the risk assessment report as to whether supervised contact with the child should be approved;
- 3. A written consent signed by the child's parent or legal guardian, if the parent or legal guardian is not the sex offender, agreeing to the sex offender having supervised contact with the child after receiving full disclosure of the sex offender's present legal status, past criminal history, and the results of the risk assessment. The court may not approve

contact with the child if the parent or legal guardian refuses to give written consent for supervised contact;

- 4. A safety plan prepared by the qualified practitioner, who provides treatment to the offender, in collaboration with the sex offender, the child's parent or legal guardian, if the parent or legal guardian is not the sex offender, and the child, when age appropriate, which details the acceptable conditions of contact between the sex offender and the child. The safety plan must be reviewed and approved by the court; and
- 5. Evidence that the child's parent or legal guardian understands the need for and agrees to the safety plan and has agreed to provide, or to designate another adult to provide, constant supervision any time the child is in contact with the offender.

The court may not appoint a person to conduct a risk assessment and may not accept a risk assessment from a person who has not demonstrated to the court that he or she has met the requirements of a qualified practitioner as defined in this section.

- (f) If the victim was under age 18, a prohibition on working for pay or as a volunteer at any place where children regularly congregate, including, but not limited to, schools, child care facilities day care centers, parks, playgrounds, pet stores, libraries, zoos, theme parks, and malls.
- (g) Unless otherwise indicated in the treatment plan provided by a qualified practitioner in the sexual offender treatment program, a prohibition on viewing, accessing, owning,
