17 Section 8. (1) The Northwest Florida Regional
18 Transportation Planning Organization, an interlocal agency under
19 part I of chapter 163, Florida Statutes, is authorized to study
20 the feasibility of advance-funding the costs of capacity
21 projects in its member counties and make ~~making~~ recommendations
22 to the Legislature by February 1, 2011 ~~2010~~. The Department of
23 Transportation may assist the organization in conducting the
24 study. The study shall be funded by the Northwest Florida
25 Regional Transportation Planning Organization with its existing
26 resources and by such other funds that may be provided from its
27 constituent counties.
