## A bill to be entitled

An act relating to the North Springs Improvement District, Broward County; amending chapter 2005-341, Laws of Florida; extending and enlarging the boundaries of the district; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 2 of section 3 of chapter 2005-341, Laws of Florida, is amended to read:

Section 2. Boundaries.-The boundaries of the district shall be:
