16 Be It Enacted by the Legislature of the State of Florida:

18           Section 1. Section 11.2421, Florida Statutes, is amended to  
19          read:

20           11.2421 Florida Statutes 2010 ~~2009~~ adopted.—The  
21          accompanying revision, consolidation, and compilation of the  
22          public statutes of 2009 ~~2008~~ of a general and permanent nature,  
23          excepting tables, rules, indexes, and other related matter  
24          contained therein, prepared by the Office of Legislative  
25          Services under the provisions of s. 11.242, together with  
26          corrections, changes, and amendments to and repeals of  
27          provisions of Florida Statutes 2009 ~~2008~~ enacted in additional  
28          reviser's bill or bills by the 2010 ~~2009~~ Legislature, is adopted  
29          and enacted as the official statute law of the state under the

30 title of "Florida Statutes 2010 ~~2009~~" and shall take effect  
31 immediately upon publication. Said statutes may be cited as  
32 "Florida Statutes 2010 ~~2009~~," "Florida Statutes," or "F.S. 2010

34 Section 2. Section 11.2422, Florida Statutes, is amended to  
35 read:

36 11.2422 Statutes repealed.—Every statute of a general and  
37 permanent nature enacted by the State or by the Territory of  
38 Florida at or prior to the 2009 ~~2008~~ regular legislative  
39 session, and every part of such statute, not included in Florida  
40 Statutes 2010 ~~2009~~, as adopted by s. 11.2421, as amended, or  
41 recognized and continued in force by reference therein or in ss.  
42 11.2423 and 11.2424, as amended, is repealed.

43 Section 3. Section 11.2424, Florida Statutes, is amended to  
44 read:

45 11.2424 Laws not repealed.—Laws enacted at the December 3-  
46 8, 2009, special session and the 2010 January 5-14, 2009,  
47 ~~special session and the 2009~~ regular session are not repealed by  
48 the adoption and enactment of the Florida Statutes 2010 ~~2009~~ by  
49 s. 11.2421, as amended, but shall have full effect as if enacted  
50 after its said adoption and enactment.

51 Section 4. Section 11.2425, Florida Statutes, is amended to  
52 read:

53 11.2425 Rights reserved under repealed statutes.—The repeal  
54 of any statute by the adoption and enactment of Florida Statutes  
55 2010 ~~2009~~, by s. 11.2421, as amended, shall not affect any right  
56 accrued before such repeal or any civil remedy where a suit is  
57 pending.
