An act relating to driving safety; creating the "Ronshay Dugans Act"; designating Drowsy Driving Prevention Week; encouraging the Department of Highway Safety and Motor Vehicles and the Department of Transportation to educate the law enforcement community and the public about the relationship between fatigue and driving performance; creating s. 316.6152, F.S.; providing definitions; restricting use of mobile telecommunications devices by school bus drivers; providing exceptions; providing

Be It Enacted by the Legislature of the State of Florida:

penalties; providing effective dates.

Section 1. This act may be cited as the "Ronshay Dugans Act."

Section 2. (1) The first week of September is designated as "Drowsy Driving Prevention Week" in this state.

(2) During Drowsy Driving Prevention Week, the Department of Highway Safety and Motor Vehicles and the Department of Transportation are encouraged to educate the law enforcement community and the public about the relationship between fatigue and driving performance and the research showing fatigue to be as much of an impairment as alcohol and as dangerous while operating a motor vehicle.

Section 3. Effective October 1, 2010, section 316.6152, Florida Statutes, is created to read:

28 316.6152 School bus driver; use of mobile 29 telecommunications device .--For purposes of this section: 30 (1)31 "Commercial mobile radio service" has the same meaning 32 as in 47 C.F.R. s. 20.3. 33 "Mobile telecommunications device" means a wireless 34 telephone or other device used to access the services of a 35 commercial mobile radio service for the purpose of sending or receiving voice, text, or other data, including, but not limited 36 to, computer data, electronic mail, electronic messages, games, 37 music, images, and video. The term "mobile telecommunications 38 39 device" includes, but is not limited to, a cellular telephone, cellular telephone accessory device, computer, game machine, 40 41 personal digital assistant, and text messaging device but does 42 not include a pager as defined in 47 C.F.R. s. 22.99.

- (2) (a) A person who is driving or in actual physical control of a public or nonpublic school bus shall not use any mobile telecommunications device.
  - (b) This subsection does not apply:
- 1. When the school bus is stopped and the engine is not running or when the school bus is stopped completely outside the normal flow of traffic; or
- 2. When the person who is driving or in actual physical control of the school bus is using the device to contact one of the following regarding an emergency situation:
  - a. A school administrator.
