18	(2)(a) There shall be a Presidential Candidate Selection
19	Committee composed of the Secretary of State, who shall be a
20	nonvoting chair; the Speaker of the House of Representatives;
21	the President of the Senate; the minority leader of each house
22	of the Legislature; and the chair of each political party
23	required to have a presidential preference primary under this

25	(b) By <u>December</u> October 31 of the year preceding the

The Secretary of 33 State shall submit such list of names of presidential candidates 34 to the selection committee on the first Tuesday after the first 35 Monday in January each November of the year a preceding the 36 presidential preference primary election is held. Each person 37 designated as a presidential candidate shall have his or her name appear, or have his or her delegates' names appear, on the 38 39 presidential preference primary ballot unless all committee 40 members of the same political party as the candidate agree to delete such candidate's name from the ballot. 41

42 (c) The selection committee shall meet in Tallahassee on the first Tuesday after the first Monday in January each 43 44 November of the year a preceding the presidential preference 45 primary is held. The selection committee shall publicly announce 46 and submit to the Department of State no later than 5 p.m. on 47 the following day the names of presidential candidates who shall 48 have their names appear, or who are entitled to have their 49 delegates' names appear, on the presidential preference primary 50 ballot. Such notification shall be in writing, by registered mail, with 52 53 return receipt requested.

(3) A candidate's name shall be printed on the presidential

presidential preference primary, an affidavit stating that he or
