Senate Amendment (with title amendment)

Between lines 846 and 847

insert:

Section 13. Subsection (5) of section 320.08, Florida Statutes, is amended to read:

320.08 License taxes.—Except as otherwise provided herein, there are hereby levied and imposed annual license taxes for the operation of motor vehicles, mopeds, motorized bicycles as defined in s. 316.003(2), and mobile homes, as defined in s. 320.01, which shall be paid to and collected by the department or its agent upon the registration or renewal of registration of

15 (5) SEMITRAILERS, FEES ACCORDING TO GROSS VEHICLE WEIGHT;
16 SCHOOL BUSES; SPECIAL PURPOSE VEHICLES.—

17 (a)1. A semitrailer drawn by a GVW truck tractor by means
18 of a fifth-wheel arrangement: \$13.50 flat per registration year
19 or any part thereof, of which \$3.50 shall be deposited into the
20 General Revenue Fund.

21 2. A semitrailer drawn by a GVW truck tractor by means of a
22 fifth-wheel arrangement: \$68 flat per permanent registration, of
23 which \$18 shall be deposited into the General Revenue Fund.

24 (b) A motor vehicle equipped with machinery and designed
25 for the exclusive purpose of well drilling, excavation,
26 construction, spraying, or similar activity, and which is not
27 designed or used to transport loads other than the machinery
28 described above over public roads: \$44 flat, of which \$11.50
29 shall be deposited into the General Revenue Fund.

30 (c) A school bus used exclusively to transport pupils to
31 and from school or school or church activities or functions
32 within their own county: \$41 flat, of which \$11 shall be
33 deposited into the General Revenue Fund.

34 (d) A wrecker, as defined in s. 320.01(40), which is used
35 to tow a vessel as defined in s. 327.02(39), a disabled,
36 abandoned, stolen-recovered, or impounded motor vehicle as
37 defined in s. 320.01(38), or a replacement motor vehicle as
38 defined in s. 320.01(39): \$41 flat, of which \$11 shall be
39 deposited into the General Revenue Fund.

40 (e) A wrecker that is used to tow any nondisabled motor
41 vehicle, ~~regardless of whether such motor vehicle is a disabled~~
42 ~~motor vehicle, a replacement motor vehicle,~~ a vessel, or any

43 other cargo, unless used as defined in paragraph (d), as
44 follows:

45 1. Gross vehicle weight of 10,000 pounds or more, but less
46 than 15,000 pounds: \$118 flat, of which \$31 shall be deposited
47 into the General Revenue Fund.

48 2. Gross vehicle weight of 15,000 pounds or more, but less
49 than 20,000 pounds: \$177 flat, of which \$46 shall be deposited
50 into the General Revenue Fund.

51 3. Gross vehicle weight of 20,000 pounds or more, but less
52 than 26,000 pounds: \$251 flat, of which \$65 shall be deposited
53 into the General Revenue Fund.

54 4. Gross vehicle weight of 26,000 pounds or more, but less
55 than 35,000 pounds: \$324 flat, of which \$84 shall be deposited
56 into the General Revenue Fund.

57 5. Gross vehicle weight of 35,000 pounds or more, but less
58 than 44,000 pounds: \$405 flat, of which \$105 shall be deposited
59 into the General Revenue Fund.

60 6. Gross vehicle weight of 44,000 pounds or more, but less
61 than 55,000 pounds: \$772 flat, of which \$200 shall be deposited
62 into the General Revenue Fund.

63 7. Gross vehicle weight of 55,000 pounds or more, but less
64 than 62,000 pounds: \$915 flat, of which \$237 shall be deposited
65 into the General Revenue Fund.

66 8. Gross vehicle weight of 62,000 pounds or more, but less
67 than 72,000 pounds: \$1,080 flat, of which \$280 shall be
68 deposited into the General Revenue Fund.

69 9. Gross vehicle weight of 72,000 pounds or more: \$1,322
70 flat, of which \$343 shall be deposited into the General Revenue
71 Fund.
