20	Moneys to be credited to the trust fund shall consist of
21	nonrecurring funds appropriated from the General Revenue Fund to
22	the Office of Tourism, Trade, and Economic Development pursuant
23	to CS for SB 2500, or similar legislation that becomes law in
24	the 2010 legislative session, and any recurring revenues as
25	specified in law.
26	(2) The Space Business Investment and Financial Services
27	Trust Fund shall be used exclusively to provide investment and
28	financial services to new, expanding, and relocating space
29	businesses, programs, and projects within this state pursuant to

31	Florida Statutes. The trust fund may not be used for personnel,
32	administrative, or overhead expenses of Space Florida, other
33	than expenses or charges directly associated with administration
34	and reporting of the fund and the fund's account.
35	(3) Notwithstanding s. 216.301, Florida Statutes, and
36	pursuant to s. 216.351, Florida Statutes, any balance in the
37	trust fund at the end of any fiscal year shall remain in the
38	trust fund and be available for carrying out the purposes of the

40	(4) In accordance with s. 19(f)(2), Article III of the
