12 (a) The department shall develop a Hispanics Settled  
13 Florida in 1565 license plate as provided in this section.

14 (b) Hispanics Settled Florida in 1565 license plates must  
15 bear the colors and design approved by the department. The word  
16 "Florida" must appear at the top of the plate, and the words

17 "HISPANICS SETTLED FLORIDA" must appear at the bottom of the  
18 plate.

19 (c) The department shall retain all revenues from the sale  
20 of such plates until all startup costs for developing and  
21 issuing the plates have been recovered. Thereafter, 25 percent  
22 of the annual use fees shall be distributed to National Hispanic  
23 Corporate Achievers, Inc., an organization in Orlando that  
24 sponsors minority job fairs. The remaining 75 percent shall be  
25 distributed to Florida Hispanic Foundation. The fees shall be  
26 used to support job and mentorship programs and to provide  
27 scholarship grants for needy students from minority communities  
28 in this state.

29 (d) By January 1, 2011, the department shall establish a  
30 method for issuing a voucher for Hispanics Settled Florida in  
31 1565 specialty license plates to allow for the presale of the  
32 plates. Issuance of the vouchers shall be contingent on payment  
33 of an application fee of \$10,000 no later than December 1, 2010.  
34 The license plate annual use fee and the processing fee required  
35 under s. 320.08056 and the service charges required under s.  
36 320.04 shall be charged for the voucher. All other applicable  
37 fees will be charged at the time of issuance of the license  
38 plate. Within 24 months after the presale voucher is  
39 established, the organization approved for presale of the  
40 Hispanics Settled Florida in 1565 specialty license plate must  
41 record with the department a minimum of 1,000 voucher sales  
42 before manufacture of the license plate can begin. If the  
43 minimum sales requirement has not been met within the 24-month  
44 presale period, the Hispanics Settled Florida in 1565 license

45 plate is deauthorized and the department shall discontinue  
46 development of the plate and issuance of the presale vouchers as  
47 prescribed in s. 320.08056(8)(b). Upon deauthorization of the  
48 plate, the purchaser of a voucher for the plate may use the  
49 annual use fee collected as a credit toward any other specialty  
50 license plate or apply for a refund on a form prescribed by the  
51 department. This paragraph expires January 1, 2012.
