**Senate Amendment (with title amendment)**

Between lines 1312 and 1313

insert:

Section 38. Paragraph (c) of subsection (16) of section 570.07, Florida Statutes, is amended to read:

570.07 Department of Agriculture and Consumer Services; functions, powers, and duties.—The department shall have and exercise the following functions, powers, and duties:

(16) To enforce the state laws and rules relating to:

(a) Fruit and vegetable inspection and grading;

(b) Pesticide spray, residue inspection, and removal;

(c) Registration, labeling, inspection, sale, and analysis

- 27 (l) Licensing of dealers in agricultural products;
- 28 (m) Administration and enforcement of all regulatory
- 29 legislation applying to milk and milk products, ice cream, and
- 30 frozen desserts;
- 31 (n) Recordation and inspection of marks and brands of
- 32 livestock; and
- 33 (o) All other regulatory laws relating to agriculture.

35 In order to ensure uniform health and safety standards, the

36 adoption of standards and fines in the subject areas of

37 paragraphs (a)-(n) is expressly preempted to the state and the

38 department. Any local government enforcing the subject areas of

39 paragraphs (a)-(n) must use the standards and fines set forth in

40 the pertinent statutes or any rules adopted by the department

41 pursuant to those statutes.
